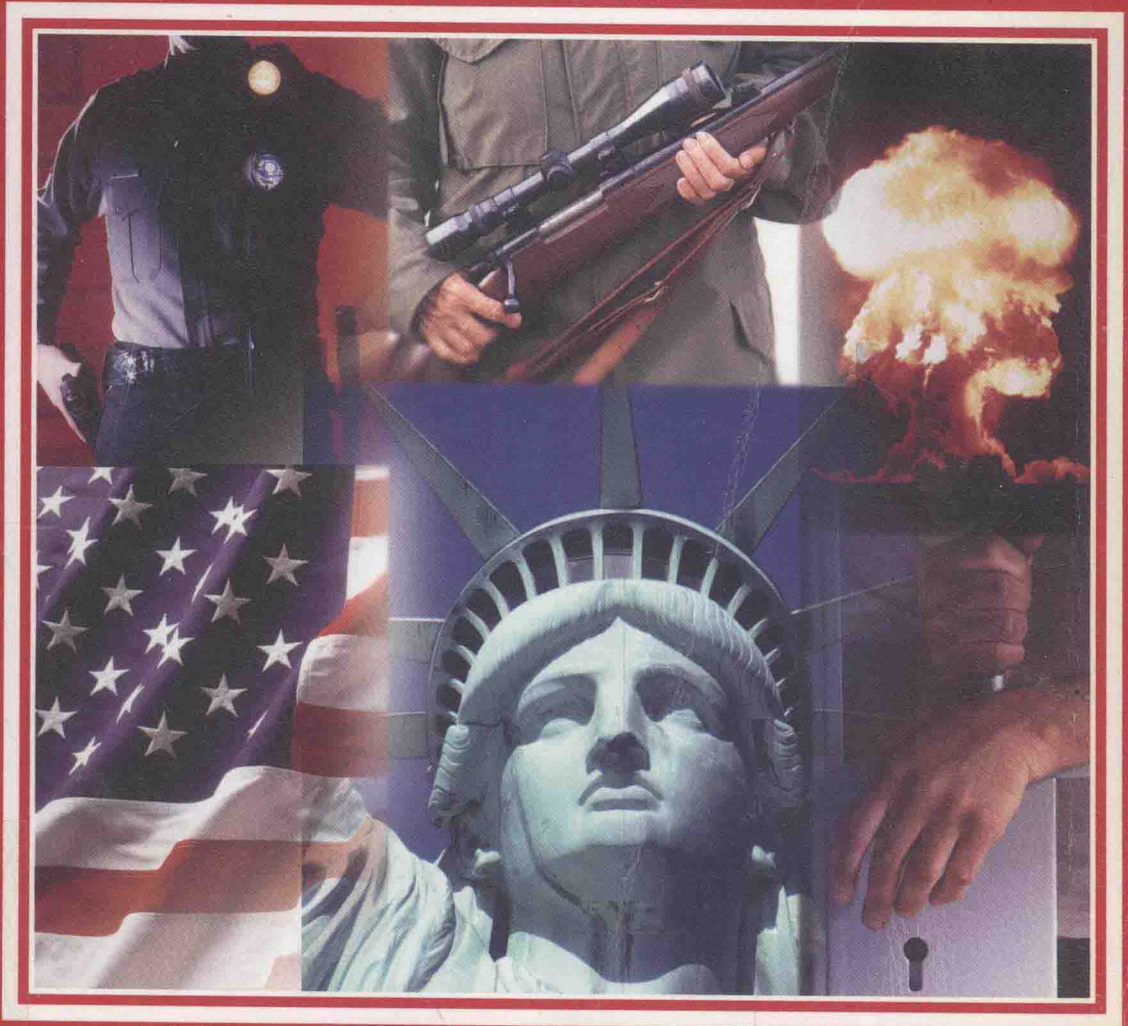

Preface to the Abridged Edition

This abridged version of the *Anti-terrorism and Criminal Enforcement* casebook, published in July, 2005, is intended for use as a Supplement to courses in Criminal Law, Criminal Procedure, Constitutional Criminal Procedure, Federal Criminal Law, or any similar course where the instructor wishes to teach a unit on, or address legal, constitutional or policy issues raised by current anti-terrorism enforcement. It can also be used as teaching materials in a Seminar on Anti-terrorism Enforcement. Like the full version of the casebook, it can be used to teach an undergraduate course in fields such as political science, public policy, criminal justice, criminology and sociology.

The emphasis in this abridged edition is on issues arising since September 11, 2001, and materials have been retained from the full version with that primary focus in mind. Because this volume is an abridgement, it includes less background material, is leaner, is less expensive and accordingly, is more practicable for use as a Supplement for courses where another casebook is being used. As in the full volume, the book “develops and plays off of the tension between a criminal enforcement or law enforcement approach, on the one hand, and wartime, military and intelligence basis, on the other.... [T]he book is not restricted to a treatment of substantive criminal issues, although it certainly includes them; nor is it restricted to process and procedure and issues of criminal law administration, An effort has been made to adopt an approach that brings together all of these different emphases in a coherent, integrated package.”

In the course of abridgement of the full casebook, some chapters have been omitted, others have been pared down; cases have been edited still further, and full versions of the underlying statutes have not been included. In addition to a Table of Contents for this edition, the Table of Contents from the full version is reprinted. This should make it convenient to identify what from the full volume has been omitted and to use it, where desired, as a source of valuable background material.

The abridged version contains significant material on issues relating to:

prosecutions under 18 U.S.C. § 2339B (providing material support to a designated foreign terrorist organization);

discussion of what kind of war the antiterrorism effort is;

extended detention as material witnesses, under immigration laws, and as unlawful combatants;

military tribunals;

the Classified Information Procedures Act;
the Foreign Intelligence Surveillance Act; and
targeted killings by U.S. agents acting abroad.
