



PREFACE

This book is now fifteen years old and in its fifth edition. I am grateful for the continued support of law teachers, students, practitioners and other readers to whom the law relating to cross border commercial transactions from the lenses of English private law holds some interest. This edition has retained the same breadth and scope of coverage as the last edition. As a textbook for both undergraduate and postgraduate courses on private international trade law, it tries to reflect as closely as possible the conventional syllabi of my law teaching colleagues. A word of thanks is due to those who responded to my request for their course syllabus.

The purpose of this textbook, like previous editions, is to provide the reader with a reasonably comprehensive package of the law into which he or she might dip. There is no requirement for the reader to start with Chapter 1 and conclude with Chapter 15. The chapters are written to be fairly self-contained, although ample cross-referencing is provided to enable the reader to make the relevant connections. Footnote references have been updated to reflect the growing literature on the subject.

I am grateful to my readers, especially colleagues, who tell me that the chapter on the Vienna Convention on the Contracts for the International Sale of Goods (CISG) which was new in the fourth edition is particularly useful to their postgraduate students. The chapter on alternative dispute resolution has been expanded, again on the basis of comments from my esteemed colleagues who teach the law of international trade in UK universities. I have tried to ensure that the larger coverage remains closely focused on dispute resolution in the area of international commerce.

The text has incorporated numerous recent cases both in the UK and elsewhere, and, legal and commercial developments. A few of the notable legal and commercial developments discussed include:
