PREFACE

When we began to plan this book we at first thought to cover the syllabuses of all the Boards offering law at "A" level. We were soon obliged to abandon this apparently attractive plan and for two connected reasons. One was that to produce a book which dealt adequately with the disparate syllabuses of the various Boards would have resulted in a text apt for no one. The other was the constraint of producing a book of manageable dimensions at a reasonable price.

In the result this book caters most obviously for students taking the examinations of the Oxford Board and the Northern Universities Joint Matriculation Board on whose syllabuses it is based. We followed these syllabuses because they are the most traditional in scope and accordingly deal with matters basic to any course in "A" level law. We have also included an appendix which lists texts for supplementary reading and reference; these texts should also cater for the special demands of other syllabuses.

If teachers of "A" level law encounter difficulties or shortcomings in the use of this book, we would be glad to enter into direct correspondence with them; and, indeed, we would welcome correspondence on any aspect of teaching law at "A" level. In this way, we hope, future editions will continue to meet the demands of teachers and students.

We owe thanks to many. To our publishers for their forbearance, courtesy and help. To Mrs. Christine Taylor and the secretarial staff for their first rate service, and to colleagues who have advised us on various parts of the text.

We have endeavoured to state the law as it was on March 31, 1983.
