

PREFACE

This book was edited by David Hayton for 30 years, between 1975 and 2005. During this time he took the book through six editions, and transformed it from an annotated collection of case extracts into a combined textbook and case-book, with extensive in-depth discussion that contextualises and illuminates selected passages from the case law. For the last (12th) edition of the book David invited me to join him as co-editor, and following his appointment as a Justice of the Caribbean Court of Justice in 2005, I have now taken over as sole editor of this (13th) edition. I am very grateful to David for entrusting me with this responsibility, and for his continued input into parts of the text, particularly Chapter 16, on trusts and the conflict of laws, which he has once more updated.

For this edition I have made some changes to the structure of the book and revised parts of the discussion to account for new developments over the past five years.
