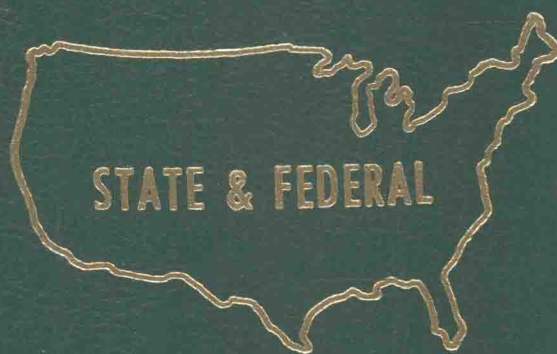

FOREWORD

Volume 70 of Am Jur 2d features the article SHIPPING, which has been completely rewritten to reflect the partial codification of the shipping laws as Title 46 of the United States Code, and other legislative activity, including the implementation of the 1972 International Regulations for Preventing Collisions at Sea and the enactment of the Inland Navigation Rules based thereon. Coverage of cases dealing with the duties of maritime carriers and limitation of their liability has also been expanded.

The other titles in this volume—SEDITION, SUBVERSIVE ACTIVITIES, AND TREASON; SEDUCTION; SUQUESTRATION; and SHERIFFS, POLICE AND CONSTABLES—have also been updated. The topic SEDITION, SUBVERSIVE ACTIVITIES, AND TREASON discusses electronic surveillance and improper use of classified information. The article on SHERIFFS, POLICE, AND CONSTABLES provides a current discussion of the duties and liabilities of sheriffs and their deputies, both as peace officers and as servers of process.

Research References are provided to Am Jur Pleading and Practice Forms (Revised), Am Jur Legal Forms 2d, Am Jur Proof of Facts, Am Jur Trials, USCS, the ALR system, Federal Procedure, L Ed, Federal Procedural Forms, L Ed, and textbooks such as *The Law of Seamen* by Norris. In addition, *Observations, Cautions, Recommendations, Practice guides, and Form drafting guides* have been inserted throughout the text to aid the practitioner. The **Table of Statutes and Rules Cited** and **Table of Parallel References** are contained in the front of the volume, and the **Index** for all of the above topics is located at the end of the volume.
