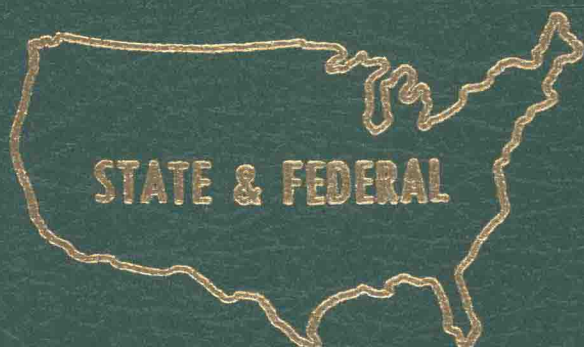

FOREWORD

This is the first of two volumes replacing 3 Am Jur 2d. The second volume is entirely devoted to the topic Aliens and Citizens.

Each of the articles in this volume has been completely re-examined and rewritten in the light of today's law. Old and rarely challenged doctrines, as well as matter of historical interest, have been condensed and made more succinct. The result is a more tightly written, updated, and comprehensive presentation of the current law.

Agency has been extensively revised to reflect recent case law, the adoption of the Restatement of Agency 2d, and the Uniform Durable Power of Attorney Act.

Adverse Possession has been updated and rewritten to improve the organization of the material.

Advertising has been revised and updated to reflect expanded regulation of outdoor advertising. The revised article covers United States Supreme Court decisions relaxing pre-existing prohibitions on advertising in various areas.
