

FOREIGN CORPORATIONS

Scope of Topic: This article discusses the legal aspects of corporations organized under the laws of other states or countries; their rights, powers, and functions in areas outside the state or country of incorporation; their duties and liabilities in this respect; the jurisdiction of local courts over them; and the effect of their dissolution and insolvency. Consideration is also given to federal corporations, multistate corporations, and the consolidation of corporations of several states.

Treated elsewhere are particular kinds of foreign corporations, such as banks and trust companies (see 10 Am Jur 2d, BANKS) and insurance companies (see INSURANCE); corporations in general (see 18 and 19 Am Jur 2d, CORPORATIONS); and license fees and taxes applicable, or as applied, to foreign corporations (see 33 and 34 Am Jur 2d, FEDERAL TAXATION; SALES AND USE TAXES; TAXATION).

Federal Aspects: The jurisdiction of federal courts over actions involving foreign corporations on the basis of diversity of citizenship or federal incorporation, and the removal of such causes of action to federal courts, are treated in an earlier article (see 32 Am Jur 2d, FEDERAL PRACTICE AND PROCEDURE).
