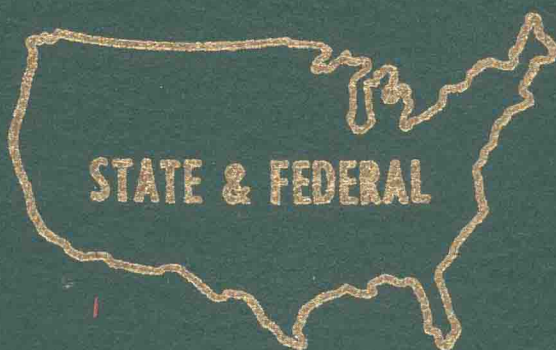

FOREWORD

The growth of the law in the areas of discovery, nonsupport, and descent since the publication of original Volume 23 in 1965 compels the rewriting of this volume.

The article on Depositions and Discovery has been extensively researched and reorganized to reflect the influence of the Federal Rules of Civil Procedure and the Federal Rules of Criminal Procedure, not only in the federal courts, but also as a model for state practice. Many states have adopted statutes or rules patterned on the Federal Rules, and other jurisdictions have incorporated comparable provisions into their practice acts. The current discussion of the discovery rules reflects the extensive amendments to the Federal Rules of Civil Procedure promulgated in 1970 and 1980.

The topic Desertion and Nonsupport reflects the increasing amount of litigation under the Uniform Reciprocal Enforcement of Support Act, which has proved to be more effective than criminal prosecutions to enforce support obligations. The article also discusses recent constitutional challenges to statutes which impose differing support requirements on fathers and mothers.

The topic Descent and Distribution includes an integrated discussion of the effect of the Uniform Probate Code on intestate succession and modern developments on the question of spousal rights.

The articles on Dedication, Deeds, and Deposits in Court have also been totally reexamined and rewritten to reflect recent developments.
