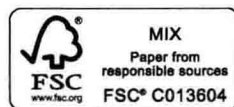

International Climate Finance

This book is the first to provide a complete overview of international climate finance. In the Copenhagen Accord of 2009, developed countries jointly committed to mobilize US\$100 billion per year to address climate change in developing countries. This book presents the best information available on this subject: an overview of current international climate finance, estimates of the incremental investment and cost of mitigation measures, estimates of the additional funding needed for adaptation, analyses of potential sources of international climate finance, and the institutional and governance arrangements to deliver the funds effectively.

Climate finance will play an increasingly important role in international efforts to address climate change over the next decade and this book is currently the only source of all relevant material on international climate finance for policymakers and researchers.

Erik Haites is President of Margaree Consultants Inc., Canada. He advises clients on economic aspects of climate change, including the design of market mechanisms and international financial mechanisms. He was a consultant to the UNFCCC secretariat during the negotiation of the rules for the Kyoto mechanisms.

He is author of seven books, fifty journal research articles, and numerous other publications and has been a Lead Author for several reports of the IPCC on mitigation.

He was guest editor for a special issue of *Climate Policy* devoted to climate finance. Dr Haites has contributed to several IPCC reports and is a Lead Author of the chapter on climate finance in AR5. He holds an MBA from McGill and a PhD from Purdue University.

Morgan Hervé-Mignucci is a Senior Analyst with Climate Policy Initiative, Venice where he deals with climate finance issues. His previous research focused on the impacts of carbon pricing on utilities investment decisions, carbon asset prices, and climate change adaptation impacts in the power sector. Prior to joining CPI, he worked for JPMorgan, EDF, and Caisse des Dépôts/CDC Climat. Morgan holds a PhD in Economics from Université Paris-Dauphine (France) and a Chartered Financial Analyst (CFA) certification.

Sergio Margulis is currently Special Advisor to the Minister of Environment in Brazil. He has previously worked for the World Bank as an Environmental Economist beginning in 1990. His last responsibility at the World Bank was as the task team leader of the Economics of Adaptation to Climate Change study. This was a very large multi-disciplinary study involving the major

sectors affected by climate change (infrastructure, agriculture, water, social, and environment) and seven developing country case studies (Vietnam, Samoa, Bangladesh, Ethiopia, Ghana, Mozambique, and Bolivia). From 2007 to 2009, Dr Margulis was Coordinator of the Brazil Economics of Climate Change Study in partnership with the British Government. He had previously worked for the World Bank's Africa Region, Latin America Region, and in the Bank's Environment Department. He was President of the Rio de Janeiro Environmental Agency between 1995 and 1996 and previously a researcher at IPEA, Ministry of Planning in Brazil. He earned his PhD in Environmental Economics from the University of London, Imperial College of Science and Technology.

Carol Mwape is currently completing a Master of Environmental Management degree at the University of Queensland. Previously she had worked for the Zambian Ministry of Tourism, Environment, and Natural Resources and negotiated climate change finance for Zambia and the Least Developed Countries Group. She served as a member of the Transitional Committee for the design of the Green Climate Fund. Carol also assisted the Zambian CDM Technical Expert in promoting the CDM in the private sector and worked with the Zambian DNA in evaluating proposed CDM projects. Urvashi Narain is a Senior Environmental Economist at the World Bank and part of the Wealth Accounting and Valuation of Ecosystem Services (WAVES) team. WAVES is a global partnership that aims to promote sustainable development by ensuring that the national accounts used to measure and plan for economic growth include the value of natural resources. Prior to joining WAVES, she co-led a three-year study at the World Bank on the Economics of Adaptation to Climate Change which provided estimates of costs of adaptation for developing countries and developed methodologies for countries to develop climate resilient development plans. Prior to joining the World Bank in 2008, she was a Research Fellow at Resources for the Future, where her research focused on poverty and environment linkages in rural economies and on global climate change policy. She earned her PhD from the Department of Agriculture and Resource Economics at the University of California at Berkeley.

Susanne Olbrisch has worked with UNDP in New York since 2008, focusing on investment and financial flows assessments for mitigation of and adaptation to climate change in Latin America, Africa, and Asia. Anand Patwardhan is currently Visiting Professor of Public Policy at the University of Maryland, College Park, USA, on leave from the Indian Institute of Technology, Bombay where he is the Shailesh J. He served as the Executive Director of the Technology Information, Forecasting and Assessment Council (TIFAC), in the Ministry of Science & Technology, Government of India from 2004 to 2008. Anand's research interests are in the area of environment–climate studies, focusing on mitigation and adaptation responses to climate change; including the diffusion and adoption of clean technology and broader issues of science, technology and innovation policy.

Mattia Romani is a Visiting Senior Fellow at the Grantham Research Institute on Climate Change and the Environment, London School of Economics and Political Science and Director of the London Office of the Global Green Growth Institute (on secondment from McKinsey), where he leads a portfolio of 15 projects across seven countries focused on the transition to a low-carbon, sustainable economic model. In 2010 he served with Lord Nicholas Stern on the UN Secretary General's High-Level Advisory Group on Climate Finance. Matthew Savage is Director of Oxford Consulting Partners, and a specialist in climate-change policy and finance. He has worked extensively for the multilateral development banks on the development of climate funds and investment strategies in Asia and Africa. He is leading adaptation finance reporting on behalf of the MDBs, and contributed to the Investment and Financial Flows (IFF) analysis for UNDP. He provided expert input to the Stern Review, and was previously an energy economics researcher at the University of Sunderland. He holds degrees from the Netherlands Business School and the University of Oxford.

Manish Kumar Shrivastava is Associate Fellow with The Energy and Resources Institute and a PhD Scholar at Jawaharlal Nehru University, New Delhi. He specializes in global environmental justice, institutional economics (particular focus on institution of market) and technological change in the context of national and global climate policy. His MPhil dissertation looked into transfer and convergence of environmental institutions across countries and its impact on technological choices made by firms. The focus of his PhD is on examining implications of market-based environmental diplomacy for 'environmental justice'. He has provided technical advice, guidance, and training on assessing climate-change impacts and adaptation to people around the world and to international organizations, the US government, states, municipalities, and the non-profit and private sectors.

Andrew Steer is President and CEO of the World Resources Institute. Until recently he was Special Envoy for Climate Change for the World Bank Group where he guided the Group's efforts on climate change in more than 130 countries, oversaw the \$7 billion Climate Investment Funds, and led the Bank's engagement on international climate negotiations. He was a member of Ban Ki-moon's High Level Panel on Sustainable Energy for All, and on the B20 Board on Green Growth. Previously he served as Director General at the UK Department of International Development (DFID) in London. Earlier, Andrew held senior posts at the World Bank, including Country Director in Vietnam and Indonesia, and Director of the Environment Department, where he oversaw a number of important innovations, including natural capital accounting and the introduction of carbon trading at the World Bank. Andrew has a PhD in Economics from the University of Pennsylvania, and is a Professor of Practice at the Fletcher School of Tufts University.

Nicholas Stern (Lord Stern of Brentford) is I.G. Patel Professor of Economics and Government, London School of Economics, Chairman of LSE's Asia Research Centre and Chairman of LSE's Grantham Research Institute on Climate Change and the Environment. From 2000 to 2003, World Bank Chief Economist and Senior Vice President; Head of the Government Economic Service, 2003–2007; Second Permanent Secretary to Her Majesty's Treasury, 2003–2005; and Director of Policy and Research for the Prime Minister's Commission for Africa, 2004–2005. Lord Stern led the Stern Review on the Economics of Climate Change, 2005–2006. He was knighted for services to economics in 2004 and made a cross-bench life peer as Baron Stern of Brentford in 2007. Lord Stern was elected President of the British Academy in July 2012 (effective July 2013).

Chiara Trabacchi is a Fellow with Climate Policy Initiative, Venice where she deals with climate finance issues. She is currently enrolled in a PhD programme on the 'Science and Management of Climate Change' at Ca' Foscari University where her research will focus on adaptation finance. Before joining CPI, Chiara worked as business strategy consultant at The European House-Ambrosetti, KPMG and Datamonitor. Chiara holds a Master's Degree in Business Administration from the Catholic University of Milan.
