PREFATORY NOTE

Legal periodicals and books published in the United States, Canada, Great Britain, Ireland, Australia and New Zealand are indexed in the *Index to Legal Periodicals & Books*. Yearbooks, annual institutes, and annual reviews of the work in a given field or on a given topic are also included. Articles must be at least five ordinary pages or two folio pages, and case notes, bibliographies, biographies, and notes of legislation at least two ordinary pages or one folio page in order to qualify for inclusion.

Periodical citations conform to *The Bluebook*, 16th edition, published and distributed by the Harvard Law Review Association.

Articles are indexed under subject and author. The most specific subject is used wherever possible; it is further subdivided by jurisdiction if an article refers to the laws of a particular jurisdiction. The subdivision "United States" is used only if an article compares the laws of the United States with those of another country.

Annual surveys of the laws of a jurisdiction or the decisions of a court are indexed under the jurisdiction. Annual surveys of the federal courts are indexed under the name of the court. Individual author contributions are not indexed.

Books are indexed under subject and author or title. Complete bibliographic information appears in author or title entries only.

Subjects and cross references used in indexing are listed in each annual cumulative volume.

DIRECTIONS FOR USE

1. The Subject and Author Index contains the bibliographical information to articles and books arranged in one alphabet. "See" references are made from variant forms of subject headings to the accepted form. "See also" references are made from a subject to related or more specific subjects under which additional material may be found.

2. Books follow articles on a given topic.

3. For the list of subject headings used in indexing consult the latest annual volume.

4. The Table of Cases lists cases alphabetically under both the plaintiff's and defendant's name. Cases are cited.

5. The Table of Statutes lists statutes by jurisdiction. Statutes are then cited alphabetically by name.

6. The Book Reviews section lists citations to reviews of current books. If a book is not found under the name of the author, it should also be searched for under the title.
