He currently teaches Amateur Sports Law, Professional Sports Law, Sports Industry Sponsorship and Marketing Workshop, and Torts. He has also taught Antitrust Law, Comparative Sports Law, International Sports Law, Legal Ethics and Professional Responsibility, and a Sports Law seminar.

Matt has co-authored a law school textbook titled *Sports Law and Regulation: Cases, Materials, and Problems* (Wolters Kluwer 2013), which is currently in its third edition, as well as an undergraduate and graduate textbook titled Sports Law: Governance and Regulation (Wolters Kluwer 2013). A leading sports law scholar, Matt has published articles in several of the nation's leading law reviews as well as in medical journals such as *The New England Journal of Medicine*. He has spoken at sports law conferences throughout the U.S. and in Australia, China, England, Korea, and Turkey.
