

General

In general this Supplement to the fifth edition of Bennion's Statutory Interpretation, which was published in 2008, aims to present the law as at 1 July 2010.

The Supplement begins with the updating of Parts I to XXIX of the Code by means of textual amendments to the affected pages in the main work.

The Supplement goes on to include updated versions of Appendix C (text of Interpretation Act 1978).

The Supplement ends with a complete updated and corrected version of the Index to the work.

Page numbering

To avoid confusion with the main work, the page numbers in the Supplement have the prefix S.

This means that in all cases a page reference in the revised Index should be checked with this Supplement. Either (if it has an S prefix) it will refer to a page contained in the Supplement or (if it does not have an S prefix) it will refer to a page in the original volume which may be modified by the Supplement.
