INTRODUCTION

Welcome to the world of corporate law. For those aspiring to become “corporate lawyers,” this book is only the first step in that journey. This course will, however, lay the groundwork for your securities and corporate finance studies and provide the foundation for your career. For those choosing other paths, we suggest that this course will also be important to you. There are few areas of the law, or indeed life, that do not cross paths with corporations. Family law lawyers will be involved in valuing corporate interests in divorce proceedings, criminal defense lawyers will be defending those involved in corporate crimes, and public interest lawyers will be attacking corporate misdeeds. This course will allow you to understand and deal with the corporation whatever your life role. More than that, we hope that you will enjoy this course as you discover the corporate law is often the result of efforts to govern intimate personal relationships among business owners.

This casebook focuses on the role that corporate lawyers play in advising their clients. That role is unique to most fields of law in that the corporate lawyer is viewed by many as a “gatekeeper” who is responsible for protecting shareholders from management depredations. That obligation may sometimes place the corporate lawyer in an awkward position. These lawyers advise management on a day-to-day basis and quite naturally treat those individual managers as the client. The scandal that followed the collapse of the Enron Corp. in 2001, however, focused attention on the role of the company’s lawyers and their perceived failures in protecting shareholders from the abuses of management. legislation was passed in the form of the Sarbanes-Oxley Act that now requires corporate lawyers to police the conduct of management and to report illegal conduct to higher authorities at the corporation. The casebook addresses that requirement and other ethical demands imposed on corporate lawyers.
