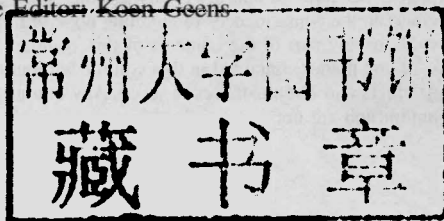

The Author



Dr Rado Bohinc (b. 1949) graduated from the University of Ljubljana, Faculty of Law (1971). He received a Master of Laws (Ljubljana, 1985) and Doctor of Law (Ljubljana, 1987). His doctoral thesis was on the relationship between property rights and corporate governance. He was appointed assistant professor at the University of Ljubljana, Faculty of Social Sciences in 1986, and has been teaching company, securities, labour and EU law since then. He served as a Minister of Science and Technology (1992–1996) and as Minister of Internal Affairs (2001–2004) in the Slovene government. In 1999 he was a Fulbright scholar at the University of California School of Law. In 2003 he was appointed a fulltime professor at the University of Ljubljana and the University of Maribor. He is President of the Council of the Slovene Science Foundation. In November 2007, he was elected rector of the University of Primorska, Slovenia.

He is an editor-in-chief of the *Company and Labour Law Review*, and author of several articles on company and securities law, labour law and EU law. He is one of the authors of the *Commentary on the Slovene Law on Commercial Companies*, edited in 2007. He has also edited several books on company law, labour and public servants' law, corporate governance, public law entities, and other subjects. His recent books (in Slovene) are *Law of the EU* (2007), *Public Law Entities* (2005), *Corporate Governance* (co-author B. Bratina) (2005), *Labour and Public Servant Relations* (2003), *Corporate Governance in the US, EU and Slovenia – A Comparative Analysis* (2000), *The Director of the Business Corporation* (co-author I. Ivanjko) (1999).
