PREFACE

This book is designed as a text for courses in American constitutional law. It consists primarily of a selection of cases designed to show how the Supreme Court has interpreted the Constitution of the United States. Emphasis is on recent cases; hence, there are separate chapters on freedom of religion, freedom of speech, equal protection of law, and criminal procedure. Cases and text updated to November 1, 1978, are included.

The first chapter contains material on the organization and operation of the federal courts and introduces the subject of judicial review. The proper place of the judiciary in our constitutional system remains a subject of interest throughout the text and explains the inclusion of many of the concurring and dissenting opinions.

My indebtedness to other authors in the field is great. I express appreciation to them, to Jeannine Hall and Joan Burns who typed the manuscript, and to Dr. Olive Hall Shadgett and Professor C. Ronald Ellington who read it and suggested many improvements that were adopted. Suggestions for further improvements from teachers, students, and others who read the printed text will be welcomed.
