## PREFACE

I take great pleasure in announcing that the first of the 17 volumes of the International Encyclopedia of Comparative Law has now been completed.

The contributors' task has been enormous, far beyond the expectations we entertained in 1965, when the work started.<sup>1</sup> Like fourteen musketeers, we agreed that, in fairness to each other, we would attempt to finish our respective chapters at approximately the same time. We aimed for the end of December 1967. In fact, it was 1971 before the first chapter appeared – the one written by John G. Fleming – and ten years were to elapse before publication of the whole volume.

The task may have been heavier than anticipated, but it has been even more rewarding. We each had a unique opportunity to take a world-wide view of the law on a particular subject – of the law as it is, of the trends in the law, and of its foreseeable development. For that reason, we owe a great debt of gratitude to the International Association of Legal Science and to Professor Dr. Konrad Zweigert, former Director of the Max-Planck-Institut für ausländisches und internationales Privatrecht, Hamburg, who launched the project.

We owe still more to Professor Dr. Ulrich Drobnig, co-director of the Max-Planck-Institut. As Executive Secretary, he was deputy to Professor Dr. Konrad Zweigert and gradually took on the whole responsibility for the endeavour. We may, at times, have suffered under the rigorous academic discipline he imposed, but we all know the extent of his devotion and self-sacrifice to duty. It is thanks to him that the International Encyclopedia of Comparative Law has reached such a high standard of scholarship, and we are all most grateful to him.

Let us now hope that our common labour will bear the fruits we intended. Encounters of civilizations have, through cross-fertilization, produced renaissances. A world-wide comparative study of law may not only spread valuable information, particularly to developing countries, but may also start a world-wide process of modernization, which would allow the law to respond better to the needs and expectations of contemporary societies. Perhaps greater mutual understanding between lawyers might even improve relations between the various communities of mankind ...
