Preface

THE publication in 1961 by Stevens & Sons of the first edition of this volume was followed by the adoption, two years later, of the Vienna Convention on Consular Relations by the United Nations Conference on Consular Relations. The Convention was a product of four major forces: restatement of existing laws (lex lata), adoption of desirable laws (lex ferenda), concordance with the Vienna Convention on Diplomatic Relations, and mutual concessions aimed at securing the widest possible adherence to the Convention. While the 1961 edition, along with the Draft Articles on Consular Relations adopted by the United Nations International Law Commission in 1961, contributed to the first two forces, there was a need for a systematic analysis of the Convention as a whole focusing, in particular, on the last two forces. This need was addressed in this author's Vienna Convention on Consular Relations (Leiden: A. W. Sijthoff, 1966) and The Vienna Conventions on Diplomatic and Consular Relations, co-authored with Philippe Cahier in the Carnegie Endowment for International Peace's International Conciliation (Jan. 1969/No. 571).

The lapse of almost three decades since the appearance of the first edition calls for a revised second edition that will not only consolidate the relevant materials of the first edition and the two subsequent publications, but also bring developments in the consular field up to date. Particular attention is given to the impact of the Vienna Convention on Consular Relations on subsequent State practice as reflected in treaties, laws and regulations, and judicial decisions, as well as to areas for possible improvement.

Foremost among those to whom I am indebted for their invaluable assistance in the preparation of this revised edition is Mrs Eileen Denza, former Legal Counsellor of the Foreign and Commonwealth Office and currently Counsel, European Communities Committee, House of Lords. An expert in diplomatic law (author of *Diplomatic Law* (Dobbs Ferry, New York: Oceana Publications, and London: The British Institute of International and Comparative Law, 1976), among others), Mrs Denza not only ably assisted me in the editing of the manuscript, but also brought

her vast knowledge in substantive fields—in both theory and practice—to bear on the improvement of the manuscript. Her tireless and conscientious input has made this book richer in content and more balanced in scope.

I would like to express my enduring appreciation to Professors Leo Gross of the Fletcher School of Law and Diplomacy and Louis B. Sohn of Harvard Law School, who together supervised my doctoral dissertation—the progenitor of this book—and encouraged me to prepare the revised edition. To Professor Ian Brownlie of Oxford University goes the credit of making possible the publication of this edition by the Oxford University Press.

I am grateful to innumerable consuls and diplomats, particularly members of the Consular Corps of Washington, whose monthly luncheon meetings are occasions not only for social gathering, but also for exchange of views and ideas towards the creation of a more effective consular system.

I am also greatly obliged to Stevens & Sons, publisher of the first edition of this book; A. W. Sijthoff, publisher of *The Vienna Convention on Consular Relations*; and other publishers for their permission to reproduce portions of my works previously published by them.

My present work in the refugee field and my Adjunct Professorship in Refugee Law at the Washington College of Law of the American University have enabled me to focus on the protection and assistance of persecuted individuals, whatever their nationality, as well as on the privileges and immunities of their protecting agencies and officials, such as the United Nations High Commissioner for Refugees (UNHCR), the United Nations Relief and Works Agency for Palestine Refugees in the Near East (UNRWA), and members of their staffs. The extension of consular-like functions to all individuals requiring protection and assistance based on human rights and the application of consular privileges and immunities, which are functional in nature, to international protecting agencies and officials, are welcome developments—further underscoring the importance of consular law.

Finally, it cannot be overemphasized that the views expressed in this revised edition, like those in the first edition, are entirely my own, and may not be attributable in any way to the Office of the United States Coordinator for Refugee Affairs or the Department of State.
