PREFACE

THIS CASEBOOK HAD ITS ORIGINS in my desire to provide students with a learning resource more in tune with the ways that law student's think and learn today. The current generation of law students has come of age in a highly technologically-sophisticated environment, with the heavy use of laptop computers and the Internet dominating the educational experience. Today it is commonplace to see 100% of the students in a classroom typing away at their computers as professors give their lectures (although many are using their computers for other distractions). The vast majority of legal research resources are now online, meaning students are much more accustomed to using electronic materials downloaded into their computers than they are with fumbling through clunky physical texts. Thus, although it is necessary for law schools to continue to inculcate in students the ability to consult hard copy materials when appropriate, it is also necessary to update the manner in which reading material is transmitted to students within law school courses.

This book was designed with the contemporary law student in mind. That focus is reflected in the content and style of the book as well as in its features. The primary purpose of a casebook is to serve as an effective learning tool for students, not as a hornbook for budding practitioners or a comprehensive treatise on the subject. Thus, here you will find a focused presentation of the core concepts central to a basic first-year education in federal civil procedure. The information is presented in a manner that is clear and easy to understand. Rather than masses of undifferentiated text, you will find the material identified and separated by headings and various text boxes that help bring the material off the page.
