Helle Tegner Anker, LL.M, PhD, is Professor of Law at the Royal Veterinary and Agricultural University, Copenhagen, Denmark. She specializes in planning law, nature conservation law, water law and other environmental law issues at the European Union (EU) as well as national level. Helle Anker is coordinator of the Nordic Environmental Law Network (NELN). She graduated from Aarhus University, Denmark.

Nicholas A. Ashford is Professor of Technology and Policy at the Massachusetts Institute of Technology (MIT), where he directs the Technology and Law Programme and teaches courses. He has written two textbooks, both currently in the process of publication: one on environmental law, policy and economics and one on technology, globalization and sustainable development. Professor Ashford holds both a PhD in chemistry and a Law Degree from the University of Chicago, where he also received graduate education in economics. He also holds adjunct faculty positions at the Harvard and Boston University Schools of Public Health. She finished her trial period as a lawyer in 2003.

Anne Christine Brusendorff holds a Master of Laws (University of Copenhagen, Denmark, and London School of Economics and Political Science, UK), and a PhD (University of Copenhagen, Denmark). She has dealt with the maritime and response fields within the Helsinki Commission (HELCOM) since 1998 and has been HELCOM executive secretary since 2003.

Hans Christian Bugge has been Professor of Environmental Law at the University of Oslo since 1998. He holds a doctorate in regional planning from the Université de Paris,

France, and is *dr. juris* of the University of Oslo, Norway. Before becoming an academic lawyer in 1991, he held various senior positions in Norway's Ministry of the Environment and its Pollution Control Authority. He has also worked with development issues, *inter alia*, as deputy minister for development cooperation.

Theofanis Christoforou has been with the European Commission Legal Service since 1984, where he is now a legal adviser. Nicolas de Sadeleer has been the recipient of one of the first EU Marie Curie chairs, which was established at the law faculty of the University of Oslo, Norway, from 2004 to 2005. He has taught law in several universities in Belgium, France, Peru, Thailand and Norway, and has worked as a consultant for several national and international authorities. Nicolas de Sadeleer's areas of research and teaching include European Community (EC) and international environmental law; health and consumer law; free movement of goods; and Belgian environmental law – subjects on which he publishes and speaks extensively. Among other publications, he is the author of *Environmental Principles* (Oxford University Press, 2002) and *Droit International et Communautaire de la Biodiversité* (Dalloz, 2004).
