## PREFACE

This year *Oxford English Law* took a giant step forward. In the spring, *English Public Law* was published. Between them *English Private Law* and *English Public Law* show that the common law can be presented in an orderly way and with reasonable brevity. Indifference to both has in the past tended to conceal its merits. While it is true that in certain contexts, notably in contested litigation, it is essential to see every finest detail, it is false to suppose that knowledge of the law cannot be taken to a high level other than at enormous length. It is less challenging to write a good long account than a short one. The contributors to these volumes are jurists of the highest authority. Their mastery each of their own field is the key to the reliability of their shorter versions. The intention is to keep these volumes constantly up to date. This year *English Public Law* is brand new, and *English Private Law*, which was first published four years ago, will for the moment stand renewed by this second cumulative supplement, which takes in developments up to the beginning of 2004. One or two later matters have been smuggled in at proof stage, but the official cut-off date remains 31 December 2003.
