The markings are easy to understand. A slash indicates word division, and a word may be separated only where a slash appears. For example, Ju'/ris/pru'/dence can be broken at three different points. However, a word should be broken at the most logical place whenever possible. Here, juris/prudence would be the most easily understood break.

If a dot or a stress mark is not followed by a slash, do not break the word at this point. These marks are aids to pronunciation only. Also, a single letter should never be separated from either the beginning or the end of a word. For example, e'qual and su'o are spelled solidly, although pronunciation indicates two syllables in each case.

Hyphenated words may be divided only after the hyphen. For example, daughter-/in-/law could be broken as follows:

daughter-	or	daughter-in-
in-law		law.

Because proper names should not be divided, they are not included in this book. Heavy stress marks are used in this book to indicate syllables receiving primary stress. The lighter marks indicate secondary stress.

The Legal Word Finder is a complete, up-to-date, and easy-to-use reference for legal secretaries, lawyers, law students, paralegals and everyone who must write or speak on the subject of the law.
