PREFACE

The number of pages in this Supplement reflects the volume of the case law since the sixth edition of Goff and Jones, *The Law of Restitution*, was published two years ago. I hope that I have discussed or noted the most important of these decisions. I would be most grateful to be told of any decision which I have missed in my trawl of the sources.

Unjust Enrichment, or Restitution, continues to attract the critical attention of many jurists. I have cited, with some critical comment, the more important articles. Three texts deserve particular mention: Professor Burrows' second edition of his properly admired *The Law of Restitution*; Dr Charles Mitchell's comprehensive monograph of *The Law of Contribution and Reimbursement*, and Professor Birks' *Unjust Enrichment*. The revision of the second edition was virtually completed before his tragically early death in July this year. Peter Birks' contribution to the development of the law of restitution, or the law of unjust enrichment as he called it, was immense. No jurist has written with greater lucid economy. He sought to bring logical structure and order to the subject, and to achieve this goal he was prepared not only to rethink what he had previously written but to challenge what many had thought were entrenched legal principles. His *Unjust Enrichment* will prove to be as seminal as his *Introduction to the Law of Restitution*.
