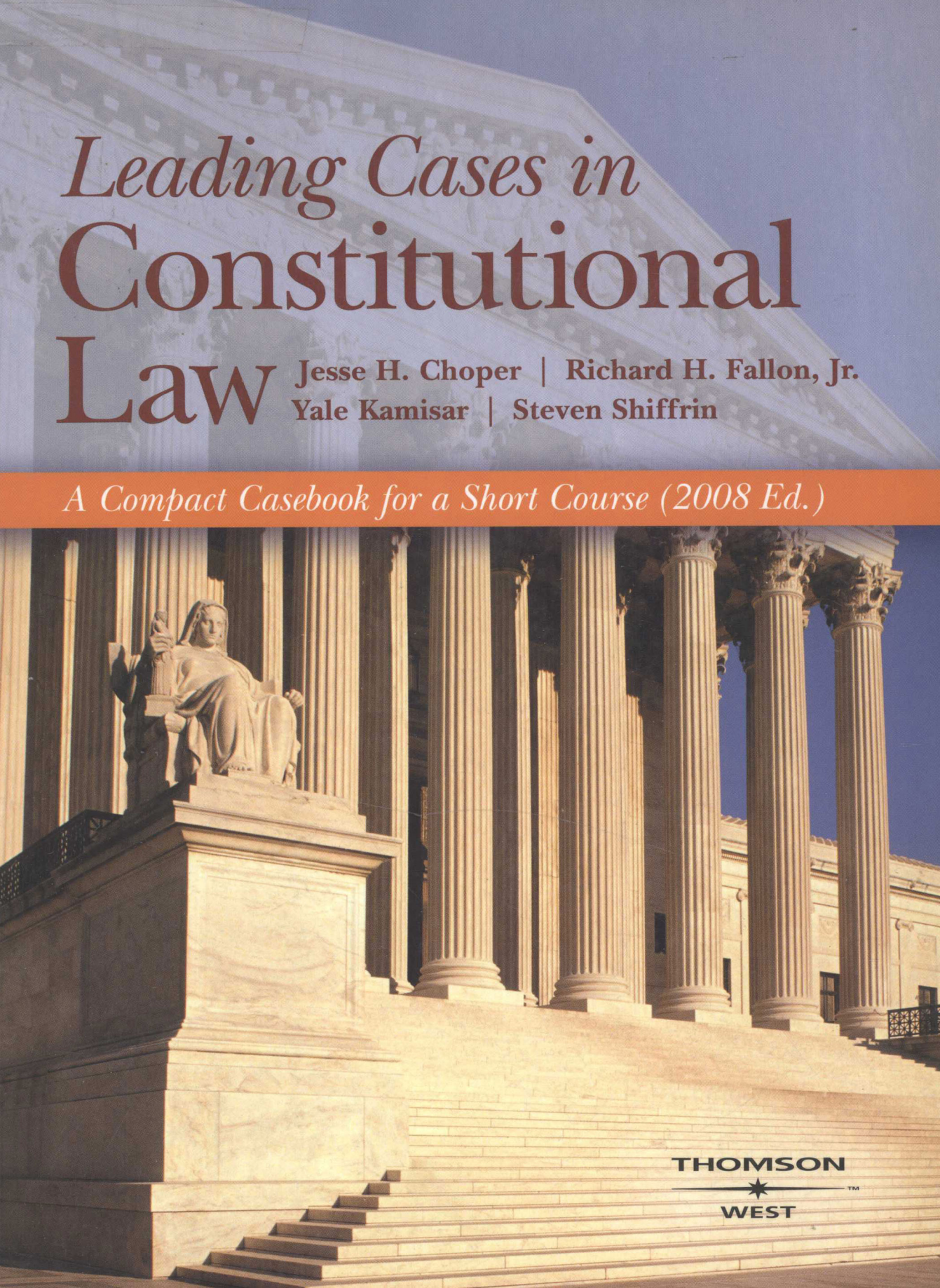

Preface

It may seem ironic that the authors of a 1600-page constitutional law casebook would turn out a compact casebook of less than 900 pages. But in recent years we have heard many of our colleagues express the need for such a book for a basic course in constitutional law—and we decided to do something about it. By judicious editing of the most important decisions of the Supreme Court and careful summarizing of less significant cases, we have sought to produce a book containing “the essentials” for a single course on the subject.

Leading Cases in Constitutional Law is published every year and includes all the significant opinions handed down during the just-concluded Supreme Court Term.

The organization of the compact book is very similar to our much larger one, which we shall continue to revise and supplement annually, and which will be available as a “resource” book for those who use this volume.

Case and statute citations, as well as footnotes of the Court, have been omitted without so specifying; other omissions are indicated by asterisks or by brackets. Numbered footnotes are from the original material; lettered footnotes are ours.
