He holds a Danish law degree, a Ph.D. (on EU company law), and a Danish dr. jur. (on joint ventures). He also obtained an LL.M. from the University of Exeter. His research is mainly focused on EU law and company law, and in these areas he has published several books and articles in both Danish and English. He is one of the two editors of the SSRN e-journal Nordic and European Company Law, and a member of the Nordic Network for Company Law.

Paul Krüger Andersen is professor of company law at the Department of Law, Business and Social Sciences, Aarhus University. He holds a Ph.D. in marketing law from 1976 and a dr. jur. from 1997 (studies in Danish corporate group law). He is the co-founder of the Nordic Network for Company Law. In 1999 he co-founded and has since been editor of the Nordic Journal of Company Law (Nordisk Tidsskrift for Selskabsret). Since 2000 he has been a member of the board of the Danish Association of Corporate Governance (DACP). In 2003 he was a legal adviser for the Latvian Companies Register. In 2004 he was appointed Distinguished Professorial Fellow at the British Institute of International and Comparative Law, London and in 2005 Dr. h.c. at the Turku School of Economics and Business Administration. He is a member of the ECGI (European Corporate Governance Institute, Brussels). Since 2007 he has been Chairman of the European Company Law Group, which aims to create a European Model Company Act. He is the author and co-author of several textbooks and numerous articles on private law, marketing law, company law and securities law.

Jan Andersson is professor of private law, particular business organizations, at Stockholm University, Sweden. He is also adjunct professor of commercial law at Jönköping International Business School, Sweden. Between 2001-2006 he was professor of private law at the Faculty of Law, University of Bergen, Norway and between 2007-2010 professor of commercial law at Jönköping International Business School. He has a Swedish Dr. Jur from Uppsala University and two LL.M. (Lund and Umeå). Since the early days of his research career his main interest has been company law and other areas closely connected to it, such as law & economics and corporate governance. He has a wide range of publications in Swedish and English. He is also a member of the Nordic Network for Company Law.

(Dalloz), France's oldest corporate law review, and is one of the editors of the European Company and Financial Law Review (www.degruyter.de/journals/ecfr). He is also a member of the European Securities and Markets Authority (ESMA) Stakeholder Group.

Luca Enriques, Professor of Business Law at the University of Bologna Faculty of Law and ECGI Research Associate, is currently on leave to serve as a Commissioner at Consob, the Italian Securities and Exchange Commission. Before entering academia, he worked for the Bank of Italy. He has been advisor to the Italian Ministry of Economy and Finance (2000–2006), and a member of the European Commission Forum of Market Experts on Auditors' Liability (2005–2007) and of the Reflection Group on the Future of EU Company Law (2010–2011). He has published various books and several articles in Italian as well as international law reviews on topics relating to company law and financial regulation.

Jesper Lau Hansen is professor at the University of Copenhagen Law Faculty, Denmark, where he is head of the research centre Forum for Company Law and Financial Market Law (FOCOFIMA). He is a member of several networks within these areas, including the Danish Corporate Governance Network and the Nordic Network for Company Law. He is Chairman of the Department of Business Law and coordinator of the International Business Law Master Program at Tilburg University. He was TPR Professor of Law at Ghent University in Belgium and visiting professor at Kyushu University Faculty of Law in Japan. He lectures regularly at Tias-Nimbas Business School and the Brabant Center of Entrepreneurship. He has worked on international projects concerned with the development of company law and corporate governance in listed and non-listed companies. He has written extensively in the area of corporate governance and venture capital. Eddy Wymeersch is Chairman of the ECGI (since November 2010) and of the Public Interest Oversight Board (Madrid). He has been Chairman of the Committee of European Securities regulators (CESR) (February 2007-July 2010) and of the European Regional Committee of IOSCO. He was Chairman of the Belgian Commission Bancaire, Financiere et des Assurances (CBFA) (chief executive 2001-2007 and Chairman of the supervisory board 2007-2010). Before joining the CBFA, Mr Wymeersch has held several public functions in Belgium ('regent' of the National Bank of Belgium from 1992, member of the legislative branch of the Council of State. Between 1990 and 2001, he was a member of the board of several Belgian companies, and from 1998 the Chairman of the Brussels airport.
