Preface

When the first edition of this book was published, the Human Rights Act 1998 had not yet entered into force in the UK, and human rights law could still be viewed as a 'foreign' subject. That of course has now changed, and in this edition of the book we have been faced with an avalanche of case-law to consider for inclusion. We have included additional Convention cases where these have been brought to our attention as meriting inclusion in the first edition, or in response to our own considerations of the earlier material, or to new cases. Our response to the current plethora of domestic cases has been to include only those which appear to us to be of the utmost significance or interest, and our watchword in the preparation of this second edition has been the first word of the title: 'essential'.

There have been a number of developments that have affected human rights case-law since the first edition. Institutional changes within the Convention architecture have altered the procedures by which case-law emerges from Strasbourg and these are dealt with in the first chapter. The accession to the Council of Europe of new States, with differing traditions, has been reflected in the work of the Court, and of course, in the UK, domestic courts have grappled with human rights issues across a wide range of areas.

In addition to the inclusion of new material, we have made some substantial reorganisation of existing material. The incidents of duplication of treatment of cases has been reduced, although we will continue to refer to cases in more than one entry where this is appropriate to the treatment of the subject matter. Material referred to in that part of the first edition dealing with discrimination has been absorbed into the substantive chapters of the book to which the discrimination relates. Nothing has been lost in this process, and we hope that the end result makes the book easier to use.

It is clear that as the role played by human rights law in the UK expands, an increasing number of cases will be come to be regarded as 'essential', and we would be pleased to hear from any reader of this book who would like to recommend material for inclusion.

In the preparation of this edition we are both jointly responsible for all the content, and any errors are ours alone. However, Susan Nash has been primarily responsible for the first chapter and areas of the book relating to criminal law, and immigration and deportation issues, while Mark Furse has been primarily responsible for the commercial areas. Other areas have been shared out more or less equally.

In the preparation of this edition the publication team at Jordans have done an excellent job in dealing with a great number of changes, and we are grateful to them for their patience and professionalism. While we have prepared this edition ourselves, and have made changes to material included in the first edition where it has been retained, we remain grateful to those who made contributions to the first edition. Contributions by Merris Amos, Leroy Bunbury, Amanda Hopkins, Charles King and Claire de Than that were present in the first edition continue to appear in this edition.

The cut off date for the inclusion of cases in this edition was 1 June 2002.
