Introduction

Cyberspace, the electronic super-highway or the Internet, as it is commonly referred to in short, even in non-English speaking parts of the world, is a globally networked, computer-sustained, computer-accessed and computer-generated multidimensional virtual reality, the use of which increases tremendously on a day by day basis. In the decision of the Supreme Court of the United States of June 26, 1997 on the constitutionality of provisions of the Communications Decency Act of 1996 enacted to protect minors from 'indecent' and 'patently offensive' communications on the Internet, it is stated that the Internet has experienced extraordinary growth. The number of computers that store information and relay communications increased from about 300 in 1981 to approximately 9,400,000 in 1996. About 40 million people used the Internet in 1996, a number that is expected to mushroom to 200 million by 1999.

In the last few years much has been written on the legal aspects of the new virtual reality. In most of these publications and also at different conferences the private international law aspects have not yet been dealt with as the main subject. It seems to me that the answers to the well-known questions: which court has jurisdiction and which law is to be applied when litigation arises from activity on the Internet, have until now been cautiously avoided. Answering these important questions by taking a closer look at the conflict aspects of the digital revolution, to think about solutions and to provide an answer for the users of the Internet and also for those who have to decide a dispute arising from the use of the Internet have been long overdue. The answers must be provided by those who are familiar with the methodology of private international law, with its possibilities, with its flexibility and also its limitations. In fact, the basic assumption of private international law is that particular actions and events can be located territorially. Since the Internet is structured logically and not geographically, notions relying on geographical locations probably no longer apply. The main question is whether the challenges created by the global information revolution to the conflicts lawyer are matters of substance or only matters of degree.

We are particularly greatful that the Hague Conference on Private International Law, upon the suggestion of its Secretary-General HANS VAN LOON, gave us the opportunity to thoroughly study these issues. This book contains seven

contributions, by distinguished lawyers, which were presented in Utrecht on June 28, 1997 at the international colloquium organized by Utrecht University's Molengraaff Institute of Private Law and the Hague Conference on Private International Law in honour of MICHEL PELICHET, Deputy Secretary-General at the time of his retirement. That the colloquium and this book are dedicated to MICHEL PELICHET is no surprise as he was the one who proposed the Internet as a potential subject for an international convention to be drafted under the auspices of the major international organisations charged with the unification of private law. In the first part of the book two introductions to the role of law in Cyberspace are given by PIERRE SIRINELLI (Paris) and MATTHEW BURNSTEIN (Nashville). In the second part of the book WILLEM GROSHEIDE (Utrecht) and FRANÇOIS DESSEMONTET (Lausanne) present the experiences in the field of intellectual property. Can private international law provide order to the chaos? forms the theme of the third part. GABRIELLE KAUFMANN-KOHLER (Geneva) and HERBERT KRONKE (Heidelberg) discuss the problems concerning jurisdiction and applicable law. Finally, the book contains some concluding remarks written by CATHERINE KESSEDJIAN (The Hague).

The editors would like to express their gratitude to those who made the organisation of the colloquium possible: substantial support was provided by the Molengraaff Institute of Private Law of the University of Utrecht, the Faculty of Law of the University of Utrecht, the Hague Conference on Private International Law, the Netherlands Ministry of Justice, the Netherlands Association of Comparative Law, Kluwer Law International and the Netherlands Research Centre 'Information, Technology and Law' (ITeR).
