But legal scholarship is much more than the faithful collection of legal data. Indeed the need for good legal scholarship is never as keenly felt as in this age of information explosion. The ability to distinguish, relative to an issue at hand, what is relevant from what is not is as treasured as ever. The ability to present systematically and intelligently, and where appropriate to analyse critically, the primary materials is what even the most powerful legal search engine does not offer.

Given the importance of disciplinary proceedings – and there are many different types covering a variety of activities in society – not only to those directly involved and the profession or vocation to which they belong, but also to society generally, it is perhaps a little surprising that a book like the present one, focusing as it does on Hong Kong law, has not appeared earlier.

PREFACE

Hong Kong, like every modern and civilised society, has experienced growth in professional services and the need for their regulation to meet minimum ethical thresholds. This book is concerned with the increasing impact of new developments in Hong Kong's large body of jurisprudence on disciplinary and regulatory proceedings relating to the professions. In addition, this book also serves to update the reader on the ever-changing ambit of laws relating to disciplinary matters. The extensive references to judgments of the Hong Kong courts are intended to enable readers to ground the principles in reality by reference to their application in real-world scenarios. In law, context is everything.

Over the last two years, against the backdrop of a worldwide financial crisis, we have witnessed considerable change in self-regulation regimes amongst professions in other jurisdictions, with independent regulators being set up to handle discipline and industry associations focusing on their educational and marketing functions. Hong Kong remains relatively unaffected by this trend and only feels its impact when required to consider the common law as practised in different jurisdictions in the context of comparative jurisprudence, such as in referencing international practice standards.

There has been a number of important developments in recent years in Hong Kong's disciplinary proceedings laws. Most notable are the requirements for legal representation and development of the role of legal advisers in disciplinary proceedings. These have now been largely settled by the Court of Final Appeal which has held that there is only one standard – a civil standard – in disciplinary proceedings. Recently, the Court of Appeal held that the rule against double jeopardy does not apply in civil service disciplinary proceedings.

The Bill of Rights and Basic Law perspectives continue to occupy much of the scene. Contractual disputes between members of the profession and their professional associations or regulators have not been as commonplace. In a sense, such questions have become a rather specialised field of administrative law.

This book is divided into two parts. Part I deals with the law of disciplinary proceedings. It chronicles the various stages of proceedings, including the misconduct, investigations, the pre-hearing, the hearing, penalties and costs, appeals and judicial review. There is a chapter devoted to current issues, which focuses on advertising, conflicts of interest and competition. Part II is divided into sub-parts dealing with various professions. These are broadly divided into medical and paramedical professions, legal professions, construction professions, the accounting profession, economic and financial professions, and certain social professions or groups, all of which have made great contributions to Hong Kong as a modern and civilised society.

The scope of this book excludes topics on prison disciplinary proceedings and disciplinary proceedings concerning conduct of students. These do not fall within the subject of 'professions'. Therefore, this book in this edition does not cover

the disciplinary jurisdiction of schools (including universities) against students or prison authorities against persons in custody.

I am very grateful to his Lordship, the Honourable Mr Justice A Cheung, Chief Judge of the High Court, who kindly agreed to write the Foreword to this book. I could not have completed this work without the support of my beloved wife, Susan who encouraged me and bore with me through the long and cold evenings in Hong Kong, and during our holiday trips, while this work was being completed. I am also grateful to Gary Soo who, without a second of hesitation, shared with me his knowledge on the code of ethics for architects, engineers and surveyors.

The law stated in this book is as it stood on 31 March 2011.

For the avoidance of doubt, any errors made in this book and the opinions expressed in various places are those of the author alone.
