PREFACE

As the title suggests, this book is intended to be an introduction to the law of property. Past editions of the book have been of use to students of property law in all Australian states. This edition is no exception. Previous editions were directed primarily to students in Victoria but this edition, where relevant, refers to statutory material and case law from all Australian jurisdictions and the United Kingdom. Although the reader has been directed to relevant differences peculiar to each state, constraints of space preclude expansive discussion of the differences and their implications.

We have attempted to state as concisely as possible the basic principles of the law of property. A considerable part of this edition has been rewritten to reflect the nature of developments in property law in recent years and the changing perspectives of the authors.

For practical reasons, the authors each took individual responsibility for specific chapters of the book and this should be borne in mind where stylistic differences become apparent. Bryan Dwyer wrote Chapters 3–8 inclusive and Joycey Tooher wrote Chapters 1, 2 and 9–14 inclusive.
