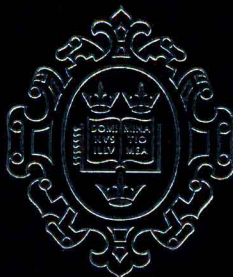

PREFACE

In the summer of 2008, the *Max Planck Encyclopedia of Public International Law* (MPEPIL) was published as an online database by Oxford University Press and has since been continually expanded. Three years on, the publication of the library edition—marking the preliminary conclusion of the Encyclopedia—offers me the opportunity to take stock and to express my gratitude to a great number of people who have contributed to this work.

I

The Encyclopedia would not have been possible without its precursors, starting with Karl Strupp's three-volume *Wörterbuch des Völkerrechts und der Diplomatie* (1924–1929). From 1960 to 1962, Hans Jürgen Schlochauer edited the *Wörterbuch des Völkerrechts* which again appeared in three volumes with an additional index volume. The Max Planck Institute for Comparative Public Law and International Law under the direction of Hermann Mosler already greatly contributed to the production of this publication.

This was followed by the *Encyclopedia of Public International Law* (EPIL), first published in installments from 1981 to 1990 under the auspices of the Max Planck Institute for Comparative Public Law and International Law under the direction of Rudolf Bernhardt. EPIL already contained twice as much material as the earlier *Wörterbücher* and, while the majority of authors still came from German-speaking countries, it was written in English with the intention of addressing scholars in all parts of the world.

The *Max Planck Encyclopedia of Public International Law* seeks to continue this renowned series of reference works. Nevertheless, MPEPIL constitutes a new work rather than a second edition of EPIL. Radical changes and developments in public international law over the last decades have made it necessary to re-write nearly every article from scratch—only 12 articles were taken verbatim from the Bernhardt edition. While nearly 350 topics were discontinued, more than twice as many were introduced. Seeking a geographical balance that would correspond to MPEPIL's thematic scope, we invited more than 800 scholars from 83 countries to contribute to the Encyclopedia, and the response was overwhelmingly positive.

Responding to the scholarly community's demands, MPEPIL was first published as a state-of-the-art online database, offering wide-ranging research functions. The articles printed in this library edition are identical to those online,

although the electronic version will continue to be expanded and updated beyond the print publication.

MPEPIL articles are hybrids in character insofar as they combine elements of a reference work with a law journal approach. Authors were asked to cover their topic in an objective, comprehensive manner but also to add a personal assessment, delineating their own scholarly view of the matter.

Quality control lay with the Advisory Board, which has convened at regular intervals since 2005. Coming from different areas of public international law, the members of the Board ensured that the various fields of international law were given adequate weight within the Encyclopedia. Every article was peer-reviewed by me and two or more members of the Advisory Board. Throughout the review and revision process, the Board (through the medium of the Heidelberg Max Planck Institute) was in constant close contact with the contributors, a synergetic procedure that considerably enriched the Encyclopedia. The Institute functioned as a point of intersection between the Board and authors, enabling a dialogue spanning legal cultures and traditions. I was surprised and delighted with how fruitful this process proved, even—or particularly—with some very controversial topics, and I am deeply indebted to the Board members for their efforts.

The purpose of this publication is a restatement of international law through global dialogue. This is reflected by the selection of keywords, which aims at covering international law in its entirety, geographically as well as substantially. Regional varieties have been treated with due brevity but so as to give the reader a helpful introduction.

II

A comprehensive publication in the field of international law that lays any claim to relevance has to take on the challenges of its time. My predecessor Rudolf Bernhardt in a mid-1990s article described the difficulties he faced when he set out to compile EPIL in the 1970s. It was the heyday of East–West antagonism; thus there was only a limited possibility of taking on East European authors.

EPIL was published in installments beginning in 1981. By the time the library edition appeared, with additional notes written in the 1990s, the Berlin Wall had come down. Bernhardt eventually had the satisfaction of seeing Central, Eastern and Western European scholars discuss international law without ideological barriers, something that had seemed impossible at the time when EPIL was projected.

Time has relegated the East–West conflict to the realm of history, but other antagonisms prevailed. By the time this present Encyclopedia was initiated, the attention of legal scholars had focused on new regional conflicts, most prominently the Middle East. As General Editor I was faced with the question whether and how to approach a dispute that seems so far from political resolution, so

far from academic agreement. Yet we tried and thus initiated a discussion that would fill a volume in itself, one that brought together many experts in one of the most exciting debates I have experienced. At the end of the day I felt that, while rapprochement may have been modest and many questions left open, the discourse we thus triggered was one of the most valuable outcomes of this Encyclopedic project. I hope it will continue well beyond the publication of this work. My sincere wish is that by the time of the next edition of the Encyclopedia this conflict will have moved from topical to historical, as happened with the East–West polarity.

The decision to cover certain politicized issues also lead to controversies within the Advisory Board itself. I would like to emphasize that the views presented in this work do not always reflect the view of individual members of the Board or the Board as a whole. I assume sole responsibility both for the decision to cover controversial ground as well as for any content in these volumes that may be seen as divisive.

Of course, it is not just conflicts and geopolitical upheavals that have stretched the limits of international law over the last twenty years. Many new normative regimes have emerged, or have been significantly expanded and solidified, such as international environmental law, international trade law, international criminal law etc. Some of the notional underpinnings of international law have been modified. Today we are moving away from statehood as the foundational paradigm of international law as we know it. We are discussing the canon of sources, new actors, new principles of law. Any reference work on international law is a snapshot of material in flux. This Encyclopedia aims to record the present state of international law but at the same time it already envisages its further development. Ideally it will become a part of that progress.
