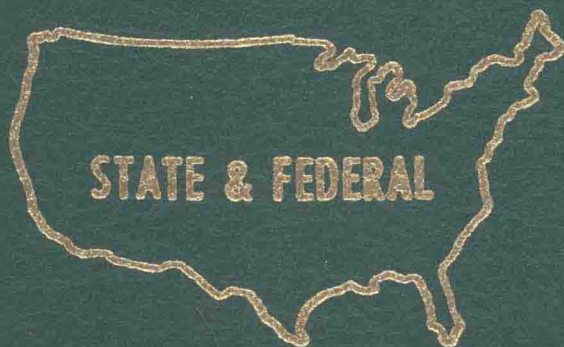

FOREWORD

Revised Volume 58 contains thoroughly updated treatment of a variety of major topics, fully reflecting the extensive evolution of the law since the publication of the original Volume 58 in 1971. For example, the new article on **New Trial** reflects an extensive survey of modern cases, involving a review of over 10,000 state and federal decisions rendered in the 18 years since the publication of the parent volume. In addition, the revised **New Trial** article is substantially rewritten to place primary emphasis on practice under state and federal procedural rules as opposed to code practice which has been largely abandoned. Similarly, the new article on **Nuisances** includes a major infusion of new case authority representative of the modern developments in the law of all jurisdictions. And the revised article **Newspapers, Periodicals, and Press Associations** contains extensive new coverage of the federal Newspaper Preservation Act, in addition to a significantly modernized collection of more generally pertinent case authorities.

Other thoroughly updated articles provide detailed coverage of **Notaries Public; Notice; Novation; Oath and Affirmation; Obstructing Justice, and Occupations, Trades, and Professions.**

To enhance the practical utility of the new articles, each article contains new special features to highlight matters helpful in evaluating and litigating a case, including **Observations, Cautions, Checklists, Recommendations, Practice guides, Federal tax guides, and Form drafting guides.** There are also numerous research references to such practice works as **Am Jur Proof of Facts, Am Jur Pleading and Practice Forms (Rev), Am Jur Legal Forms 2d, Am Jur Trials, Federal Procedure, L Ed, and Federal Procedural Forms, L Ed,** as well as extensive references to **ALR2d, 3d, 4th, and ALR Federal** for exhaustive case coverage on specific points of the text.

A **Table of Statutes and Rules Cited** and a **Table of Parallel References** are contained at the front of the volume, and an **Index** covering the articles in the volume appears at the end of the volume.
