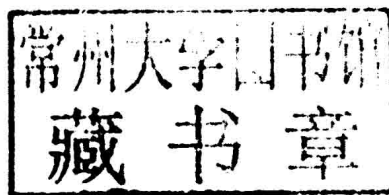

This book started life as Lecture Notes on Criminal Litigation and Sentencing, based on lectures given to students on the Bar Vocational Course (now known as the Bar Professional Training Course) at the Inns of Court School of Law (now part of The City Law School, at City University London). The book grew in size with each successive edition. This edition has gone through a rigorous exercise programme and is now rather slimmer as a result.
