## Preface

Barely three years have passed since the seventh edition of this book appeared. The principal events in the intervening period have been the coming into effect of three EU Regulations. In the last edition an account could be given of the Rome I Regulation on contractual obligations and the Rome II Regulation on non-contractual obligations (especially those in the area of tort or delict) but neither Regulation was in force. It will still be some time before decisions of the courts confirm or correct the opinions of commentators as to the precise effect of those instruments. These Regulations have been joined by Regulation 4/2009, the Maintenance Regulation, and the related work at The Hague (in which I was able to take an active part), the Convention on the International Recovery of Child Support and Other Forms of Family Maintenance and the Protocol on the Law Applicable to Maintenance Obligations. There has been a good deal of case law on the Brussels I (notably *West Tankers Inc v Allianz SpA*) and Brussels IIa Regulations, all duly incorporated in the text of this edition.

The EU continues to develop its system of private international law, but the United Kingdom has chosen not to be party to the instruments, actual or proposed, on choice of law in divorce, on matrimonial property and on wills and succession. These decisions are important for the future of our subject, for the approach and insights of the common law tradition were in danger of being all but eliminated in favour of those of the civil law. It is to be hoped that the coming recast of Brussels I Regulation may see the recovery of a little of the lost ground.

This book continues to seek to cover the principal areas of the conflict of laws. The tendency in some universities to reduce the scope of the subject to international commercial law (and so in practice for it to be almost wholly concerned with material from EU sources) deprives the student of the opportunity to see how this subject works across the whole field of law. We remain convinced that family law and property law remain important, not only in practice but to an understanding of the subject.

The Supreme Court of the United Kingdom has begun work. We share the general dismay that Lord Collins of Mapesbury, the doyen of our subject, had such a short tenure of office as a Justice. The court has already made some significant contributions, in decisions such as those in *Lucasfilm Ltd v Ainsworth*, *Granatino v Radmacher* and *Re E (Children) (International Abduction)*.

Another court, the European Court of Human Rights, has begun to have an impact on our subject. Its judgments in two child abduction cases, *Neulinger v Switzerland* and *Sneersone v Italy*, have caused a degree of consternation. The Hague Child Abduction Convention has its critics, but the voluminous body of

case law (in England and elsewhere) provided clear guidance. The Strasbourg Court's decisions sadly create doubts and uncertainty.

New to this edition is the contribution of Verónica Ruiz Abou-Nigm. The birth of her third child prevented Verónica from taking as large a role in this edition as I had hoped. However, she did take the major responsibility for chapters 4, 5, 6 and 11, chapters most affected by the developments of the last three years. Every chapter has been carefully revised (who would have expected an important case on legitimacy?), with a deal of subtle re-writing and some re-ordering. The book still benefits from Kisch Beevers' contributions to the last two editions.

This is still John Morris's book in its scope and general approach. There are some lengthy passages, especially in the property chapters, which are virtually unchanged from his last (3rd) edition. He was a great, if occasionally terrifying, teacher and an exacting but generous colleague. As in each new edition, I salute his memory.
