

FOREWORD

Greatly increased activity of the legislatures and courts, particularly in the area of civil rights, has resulted in explosive new developments and widespread changes mandating the rewriting of Volume 15 Am Jur 2d which is now being reissued as Volumes 15 and 15A.

Since 1964, when the original Volume 15 appeared, the federal law of civil rights has been completely revamped by a series of far-ranging statutes, including:

The Civil Rights Act of 1964

The Equal Employment Opportunity Act of 1972

The Age Discrimination in Employment Act of 1967

The Age Discrimination Act of 1975

The Fair Housing Act of 1968

(Title VIII of the Civil Rights Act)

The Education Amendments of 1972

These changes, and similar activity in the state legislatures, have produced a spate of case decisions expounding and interpreting these statutes. Civil rights has now become one of the most active areas of litigation affecting every aspect of business and social life.

In the twelve years since Volume 15 was first issued, there has also been greatly increased activity by courts and legislatures in other areas covered by that volume, such as condominium law, with condominiums now having become one of the fastest growing modes of property ownership.

These and the other subjects covered in the original volume 15 Am Jur 2d have now been completely researched and rewritten in the light of today's statutes and decisions, so that you will have in your new Volumes 15 and 15A, a comprehensive, reliable, and up-to-date treatment of these important fields.
