

Introduction to the Scottish Qualifications Authority

This Unit **D76H 35 Professional Issues in Computing** has been devised and developed by the Scottish Qualifications Authority (SQA). Here is an explanation of the SQA and its work:

The SQA is the national body in Scotland responsible for the development, accreditation, assessment, and certification of qualifications other than degrees.

Its website can be viewed on: www.sqa.org.uk.

SQA's functions are to:

- devise, develop and validate qualifications, and keep them under review
- accredit qualifications
- approve education and training establishments as being suitable for entering people for these qualifications
- arrange for, assist in, and carry out, the assessment of people taking SQA qualifications

- quality assure education and training establishments which offer SQA qualifications
- issue certificates to candidates.

In order to pass SQA units, students must complete prescribed assessments. These assessments must meet certain standards.

The Unit Specification outlines the five Outcomes that students must complete in order to achieve this Unit. The Specification also details the knowledge and/or skills required to achieve the Outcomes. The Evidence Requirements prescribe the type, standard and amount of evidence required for each Outcome.

Introduction to the Unit

2.1 What is the Purpose of this Unit?

This Unit is designed to provide you with an extensive understanding of the context within which they will work as computing professionals.

The Unit will provide you with a broad knowledge of the ethical, social and legal aspects of professional computing environments.

This Unit is primarily intended for candidates who propose to follow a career, or are following a career, as computing professionals and who require an understanding of the professional responsibilities of such employment.

2.2 What are the Outcomes of this Unit?

There are five Outcomes:

- 1. Discuss the role of professional institutions in computing.
- 2. Describe the legislation that applies to the computing profession.
- Explain the major codes of conduct in the computing profession.

- 4. Explain the meaning and importance of intellectual property for the computing profession.
- 5. Demonstrate an awareness of the application of ethics to the computing profession.

The learning material throughout this unit is designed to get you thinking and asking questions of yourself.

Where decisions are made based on your own belief systems and morals, it is important to be aware of the 'bigger picture'. Of course, you must always conduct yourself within the boundaries of the law so that an awareness of relevant legislation is also important.
