# Preface

Since the publication of the original edition of this book some four years have slipped by and developments have taken place in the various subjects covered by this work. Several chapters have become increasingly in need of updating. For example, the chapter on Limitation of Liability has, in this second edition, been given greater depth on the 1976 (London) Convention in view of its now imminent coming into effect. Also the very significant, and controversial, court ruling in *The Marion* case (at House of Lords level) has been written into the chapter.

The Oil Pollution chapter has been updated with an account of the 1984 Protocol to the 1969 CLC, the latest developments in Tovalop and Cristal, an account of the Chicago judgment in *The Amoco Cadiz* and the implementation of MARPOL 73/78.

The chapter on Jurisdiction has received more restructuring than any other, largely due to the replacement of the 1956 Administration of Justice Act (Part I) by the Supreme Court Act 1981. Significant recent cases have been written into the text, for example *The Maritime Trader* and *The Span Terza*. Maritime liens have been given enlarged treatment.

Pilotage has been updated by reference throughout the chapter to the 1983 Pilotage Act. Towage has been updated by commentary on the 1983 Standard Towage Conditions, which have replaced the 1974 version. The text of the 1983 Conditions now appears as an appendix to the chapter.

The Norwegian Saleform has replaced the Japanese form as an appendix to Chapter 3 and commentary on the 1983 revision of the form, with appropriate illustrative cases, has been written into the text of the chapter.

The chapter on Collisions has been brought up to date with reference to the 1983 Collision Regulations and the addition of two or three recent law cases as illustrations.

Commentary on Salvage has been enlarged and developed, particularly on the 1980 revision of Lloyd's Open Form.

Generally speaking, it continues to be my aim, as I mentioned in the Preface to the first edition, to explain the law through the 'eyes' of the cases and judicial rulings as case law is such an inherent and vital part of English law and its true and reasonable development.

I should like to take this opportunity to express my confidence, however humble this statement may be, that the shipping industry will 'weather the storm of recession' and will survive to grow again and prosper and become once again the proud and respected industry which it was in the better days gone by. If it does not survive then surely we all perish, because without sea carriage international trade itself would suffer a mortal blow.

During the preparation of this second edition my thanks are again due to Captain G. White for his assistance and advice on seamen's contracts of employment and I would like also to thank certain members of the staff of the United Kingdom Departments of Trade and of Transport who so kindly and courteously from time to time gave me information over the telephone on various recent amendments to sundry statutes which feature in this edition. I respect the wishes of those kind and helpful people that they should remain incognito.

I have tried to ensure that the law as set out in this book is such as was prevailing as at 31 December 1984.
