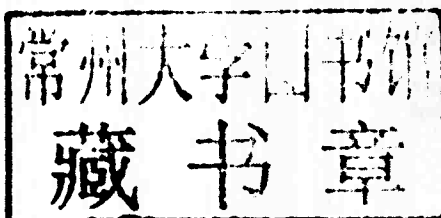

Anthony Bale is Professor of Medieval Studies at Birkbeck, University of London. He has published widely in the field of medieval religious writing and the representation of Jews; he recently published a new translation and edition of Sir John Mandeville's *Book of Marvels and Travels* (2012).

Sarah Beckwith is Professor of English, Theater Studies and Religious Studies at Duke University. She is the author of *Christ's Body: Identity, Culture and Society in Late Medieval Writings* (1993), *Signifying God: Social Act and Symbolic Relation in The York Corpus Christi Play* (2001) and, most recently, *Shakespeare and the Grammar of Forgiveness* (2011). She was coeditor of the *Journal of Medieval and Early Modern Studies* for several years and is a coeditor (with David Aers and James Simpson) of the series Re-Formations (University of Notre Dame Press).

Ardis Butterfield joined the English faculty at Yale as a Professor of English in July 2012. Previously she was Professor of English at UCL, a Leverhulme Senior Research Fellow, and a Visiting Fellow at All Souls College, Oxford. Her most recent book, *The Familiar Enemy: Chaucer, Language and Nation in the Hundred Years War* (2009), won the 2010 R.H. Gapper prize for French Studies. Her current projects include *Chaucer: A London Life*, an edition of medieval English lyrics for Norton, and a book on lyric form in the middle ages: *Living Form: The Origins of Medieval Song*.

Christopher Cannon is Professor of English at New York University, and has also taught at UCLA, Oxford and Cambridge. He is the author of *Middle English: A Cultural History*

(2008), *The Grounds of English Literature* (2004), and *The Making of Chaucer's English* (1998). He has co-edited (with Maura Nolan) *Medieval Latin and Middle English Literature: Essays in Honour of Jill Mann* (2011) and (with Rita Copeland and Nicolette Zeeman) a special issue of *New Medieval Literatures* (2009), "Medieval Grammar and the Literary Arts."

Christine Chism is an Associate Professor in English at UCLA and the author of *Alliterative Revivals* (2002). Recently she has also been working on the medieval Mediterranean and on the Arabic and European travel narratives of Ibn Battuta, Ibn Jubayr, John Mandeville, and Marco Polo; and the Middle English and Arabic Alexander romances.

Lisa H. Cooper is Associate Professor of English at the University of Wisconsin-Madison. Author of *Artisans and Narrative Craft in Late Medieval England* (2011) and co-editor of *Lydgate Matters: Poetry and Material Culture in the Fifteenth Century* (2008), she is currently working on a book about the intersection of the practical and the poetic in late medieval literature.

Susan Crane is Parr Professor of English and Comparative Literature at Columbia. Three of her books explore questions raised in the present essay. *Insular Romance* (1986) argues that aristocratic identities and concerns enliven the genre of romance. *Gender and Romance* (1994) outlines discursive versions of sexuality such as chivalric masculinity. *The Performance of Self* (2002) delineates pre-modern identity as it was expressed in secular rituals such as tournaments. Her most recent book *Animal Encounters* (2012) explores how cross-species relationships were practiced and conceived in medieval Britain.

Holly A. Crocker is Associate Professor of English at the University of South Carolina. She is author of *Chaucer's Visions of Manhood* (2007) and editor of *Comic Provocations: Exposing the Corpus of Old French Fabliaux* (2006). Currently she is completing a book entitled *The Matter of Virtue: Women's Ethical Action from Chaucer to Shakespeare*. She has received fellowships and grants from the German Fulbright Commission, the Folger Shakespeare Library and the National Endowment for the Humanities.

George Edmondson is Associate Professor of English at Dartmouth College. He is the author of *The Neighboring Text: Chaucer, Boccaccio, Henryson* and the coeditor, with Klaus Mladek, of *Sovereignty in Ruins: The Crisis of Politics*. His current work focuses on the connection between biopolitics and the theme of exile and return, and on the category of the creature. With Klaus Mladek, he is engaged in a collaborative project with the working title *A Politics of Melancholia*.

Ruth Evans is Dorothy McBride Orthwein Professor of English at Saint Louis University. She is Executive Director of the New Chaucer Society. Her major research interests are in medieval literature and cultural history of the period 1300–1580, with particular focuses on gender, sexuality, translation, and memory. Her latest publication is an edited volume, *A Cultural History of Sexuality in the Middle Ages*, Volume 2 of Berg's Cultural History of Sexuality series (2011).

Sylvia Federico is Associate Professor of English at Bates College, where she teaches introductory and advanced courses in late medieval literature, language, and culture. She is currently writing a book about the shared classical styles of Chaucer and Walsingham.

Laurie Finke is Professor of Women's and Gender Studies at Kenyon College. She is the author of *Feminist Theory, Women's Writing* and *Women's Writing in English: The Middle Ages*, and, with Martin Shichtman, of *Cinematic Illuminations: The Middle Ages on Film and King*

Arthur and the Myth of History. She is an editor of the *Norton Anthology of Criticism and Theory* and coeditor with Shichtman of *Medieval Texts and Contemporary Readers*. She has also authored numerous articles on medieval literature, medievalism, literary theory, and film.

L. O. Aranye Fradenburg is Director of the Program for Literature and the Mind and Professor of English at the University of California, Santa Barbara. She is also a Clinical Associate at the New Center for Psychoanalysis, Los Angeles. She has written numerous articles and books on medieval literature and psychoanalysis, including *Sacrifice Your Love: Psychoanalysis, Historicism, Chaucer* (2002).

Frank Grady is Professor of English at the University of Missouri-St Louis, where he teaches courses in medieval literature, literary theory, and film.

Richard Firth Green is a Professor of English at The Ohio State University. He is author of *A Crisis of Truth: Literature and Law in Ricardian England* (1998), *Poets and Princepleasers: Literature and the English Court in the Late Middle Ages* (1980) and numerous articles in such journals as *Speculum*, *Medium Aevum*, *Chaucer Review*, and *Studies in the Age of Chaucer*. He is a former John Simon Guggenheim Fellow (1989–1990), and a past president of the New Chaucer Society (2008–2010).

Bruce Holsinger, Professor of English at the University of Virginia, is a recipient of fellowships from the NEH, the ACLS, and the Guggenheim Foundation, and his books have won awards from the Medieval Academy of America, the Modern Language Association, and the American Musicological Society. His first novel, *A Burnable Book* (2014), is set in Chaucer's London in 1385.

Patricia Clare Ingham is Associate Professor of English and Medieval Studies at Indiana University in Bloomington. She serves as one of the editors for *Exemplaria*, a *Journal of Theory in Medieval and Renaissance Studies*. The author of *Sovereign Fantasies: Arthurian Romance and the Making of Britain* and coeditor of *Postcolonial Moves, Medieval Through Modern*, she has published articles on a range of topics, including Chaucer, medieval romance, historiography, and psychoanalytic, postcolonial, and gender theories.

Hannah Johnson is Associate Professor of English at the University of Pittsburgh. Her first book, *Blood Libel: The Ritual Murder Accusation at the Limit of Jewish History* (2012), examines the entanglement of concerns about methodology, ethics, and ideology in some recent historiography on one of the most inflammatory anti-Jewish legends of the Middle Ages. With Heather Blurton, she is currently co-authoring a book entitled *Chaucer's Prioress and the Jews: Ethics, Criticism, and Antisemitism*, analyzing the modern history of criticism and debate surrounding "The Prioress's Tale".

Steven Justice is Professor of English at the University of Mississippi and at the University of California, Berkeley. He is author of *Writing and Rebellion: England in 1381* (1994); two recent essays closely related to the one in this volume are "Eucharistic Miracle and Eucharistic Doubt" (2012) and "'Most Impudent': Augustine, After Augustine, and Way After Augustine" (2014), both in the *Journal of Medieval and Early Modern Studies*.

David Lawton has worked in Australia, Britain and the US, and is currently Professor of English at Washington University in St Louis. He was Leverhulme Visiting Professor at Oxford 2009–2010, was Executive Director of the New Chaucer Society 2002–2012, and is a founding editor of *New Medieval Literatures*. He has worked on voice in late

medieval literature since the 1980s and his new book, *Voice and Public Interiorities*, is forthcoming. He also works on Bible translation and on blasphemy.

Robert Mills was Senior Lecturer in English at King's College London before joining the History of Art Department at University College London in 2012. He is author of *Suspended Animation: Pain, Pleasure and Punishment in Medieval Culture* (2005) and coeditor of *The Monstrous Middle Ages* (2003), *Troubled Vision: Gender, Sexuality, and Sight in Medieval Text and Image* (2004), and *Rethinking Medieval Translation: Ethics, Politics, Theory* (2012). Recently he has completed a book on visualizations of sodomy in the Middle Ages.

J. Allan Mitchell is Associate Professor of English at the University of Victoria, Canada. He has explored connections between medieval rhetoric and vernacular ethics in two books, *Ethics and Eventfulness in Middle English Literature* (2009) and *Ethics and Exemplary Narrative in Chaucer and Gower* (2004). Currently he is completing a book project called "Becoming Human: Essays on Organisms, Objects, and Premodern Ecologies" about the creative conjugations of living and nonliving things.

Nicholas Perkins is a Fellow of St Hugh's College, University of Oxford, and University Lecturer in Medieval English. He is the author of *Hoccleve's 'Regiment of Princes': Counsel and Constraint* (2001), and, with Alison Wiggins, *The Romance of the Middle Ages* (2012), linked to a major exhibition at the Bodleian Library: <http://medievalromance.bodleian.ox.ac.uk>. His other publications range from Gildas to *Ancrene Wisse*, John Lydgate and contemporary medievalisms. His current project examines the role of gifts, objects and exchanges in medieval romance narrative.

Tison Pugh is Professor in the Department of English at the University of Central Florida. He is the author of *Queering Medieval Genres, Sexuality and Its Queer Discontents in Middle English*, and the forthcoming *Queer Chivalry: Medievalism and the Myth of White Masculinity in Southern Literature*. He has also edited *Approaches to Teaching Chaucer's Troilus and Criseyde and the Shorter Poems* (with Angela Jane Weisl); *Race, Class, and Gender in "Medieval" Cinema* (with Lynn Ramey); *Men and Masculinities in Chaucer's Troilus and Criseyde* (with Marcia Marzec); and *Queer Movie Medievalisms* (with Kathleen Kelly).

Elizabeth Robertson is Professor and the Samuels Chair of English language at the University of Glasgow. Co-founder of the Society for Medieval Feminist Scholarship, she has published widely on the topic of gender and religion in medieval English literature from the *Ancrene Wisse* to Chaucer and Langland in books, coedited collections of essays and journals such as *Speculum* and *Studies in the Age of Chaucer*. She is also coeditor with Stephen Shepherd of the *Norton Critical Edition of Piers Plowman*. She is currently completing *Chaucerian Consent: Women, Religion and Subjection in late medieval England*.

Kellie Robertson is an Associate Professor of English at the University of Maryland. She is the author of *The Laborer's Two Bodies: Labor and the "Work" of the Text in Medieval Britain, 1350–1500* (2006) and coeditor (with Michael Uebel) of *The Middle Ages at Work: Practicing Labor in Late Medieval England* (2004). Her current book examines late medieval poetry in the context of natural philosophy, arguing that both domains struggled over how to represent nature in the wake of Aristotelian science.

Jessica Rosenfeld is Associate Professor of English at Washington University in St Louis. She is the author of *Ethics and Enjoyment in Late Medieval Poetry: Love after Aristotle* (2011). Her research interests include medieval moral philosophy, psychoanalysis, the literature

of confession, and the history of emotions. She is currently writing a book about envy from Aristotle to Freud and beyond, with particular attention to medieval discourses on the vices and virtues.

Sarah Salih is Senior Lecturer in English, King's College London. She has written *Versions of Virginity in Late Medieval England* (2001), edited *A Companion to Middle English Hagiography* (2006), coedited *Gender and Holiness: Men, Women and Saints in Late Medieval Europe* (2002), *Medieval Virginites* (2003), *Julian of Norwich's Legacy: Medieval Mysticism and Post-Medieval Reception* (2009), and *Locating the Middle Ages: The Spaces and Places of Medieval Culture* (KCLMS, 2012). She is a member of the Steering Group of the Gender and Medieval Studies, a member of the editorial board of *Different Visions*, and incoming editor of *Studies in the Age of Chaucer*.

Corinne Saunders is Professor of English and Associate Director of the Centre for Medical Humanities at the University of Durham. She specializes in medieval literature, particularly romance, and the history of ideas. She is the author of *The Forest of Medieval Romance* (1993), *Rape and Ravishment in the Literature of Medieval England* (2001), and *Magic and the Supernatural in Medieval English Romance* (2010). Her edited books include *A Companion to Medieval Poetry* (Blackwell, 2010). She is English editor of the journal *Medium Ævum*.

Martin B. Shichtman is Director of Jewish Studies and Professor of English Language and Literature at Eastern Michigan University. With Laurie A. Finke he has written *Cinematic Illuminations: The Middle Ages on Film* (2010) and *King Arthur and the Myth of History* (2004). He is coeditor with James P. Carley of *Culture and the King: The Social Implications of the Arthurian Legend* (1994), and, with Laurie A. Finke, of *Medieval Texts and Contemporary Readers* (1987). He has also authored numerous articles on medieval literature, contemporary literary theory, and film.

D. Vance Smith is Professor of English at Princeton University. He is author of *Arts of Possession: The Middle English Household Imaginary* (2003), *The Book of the Incipit: Beginnings in the Fourteenth Century* (2001) and coeditor with Andrew Cole of *The Legitimacy of the Middle Ages: On the Unwritten History of Theory* (2010). Currently he is completing a book entitled *Dying Medieval: The Termination of Middle English Literature*. He has received fellowships and grants from the Guggenheim Foundation, the UK Fulbright Commission, the National Humanities Center, the National Endowment for the Humanities, and the American Council of Learned Societies.

Emily Steiner is Associate Professor of English and an award-winning teacher at the University of Pennsylvania. She is the author of *Documentary Culture and the Making of Medieval English Literature* (2003) and *Reading 'Piers Plowman'* (2013), as well as coeditor with Candace Barrington of *The Letter of the Law: Legal Practice and Literary Production in Medieval England* (2002). She is coeditor with Rebecca Davis of the *Yearbook of Langland Studies*.

Jennifer Summit is Professor of English at Stanford. She works across medieval and early modern literature on the histories of literacy and disciplinary knowledge. She is the author of *Lost Property: The Woman Writer and English Literary History, 1380–1589* (2000) and *Memory's Library: Medieval Books in Early Modern England* (2008; paperback, 2011), and is currently finishing a book with Blakey Vermeule (Stanford) on the active life vs. the contemplative life.

Stephanie Trigg is Professor of English Literature at the University of Melbourne, and is also a Chief Investigator with the Australian Research Council Centre of Excellence for

the History of Emotions. She is author of *Congenial Souls: Reading Chaucer from Medieval to Postmodern* (2002) and *Shame and Honor: A Vulgar History of the Order of the Garter* (2012). She has also published an edition of *Wynnere and Wastoure* (1990) and essays on medieval poetry, medievalism, and Australian poetry.

Marion Turner is Tutorial Fellow in English at Jesus College, University of Oxford. She is the author of *Chaucerian Conflict: Languages of Antagonism in Late Fourteenth Century London* (2007) and of many articles, especially on Chaucer. In 2013 she edited *A Handbook of Middle English Studies* for Wiley-Blackwell in their Critical Theory Handbooks series, and she is also editing a special issue of the *Journal of Medieval and Early Modern Studies* on medical discourse in premodern Europe. Marion is currently working on a biography of Chaucer for Princeton University Press.

David Wallace has been Judith Rodin Professor of English at the University of Pennsylvania since 1996, with visiting appointments at Melbourne, London, Princeton, and Jerusalem. His BBC documentary radio features include *Malory: a Tale of Two Texts*. His most recent books are *Premodern Places: Calais to Surinam, Chaucer to Aphra Behn* and *Strong Women: Life, Text, and Territory, 1347–1645*.
