Preface to the Fourth Edition

Insolvency law has developed apace since the date of the third edition of this work. Foremost in these developments has been the emergence of administration substantially replacing liquidation and the appointment of administrative receivers as the mechanism for the management of the affairs of companies which have fallen on hard times. This development is reflected in the changes both in the title of this work from "The Law of Receivers and Administrators of Companies" to "The Law of Administrators and Receivers of Companies" and in its contents which now afford equal consideration to administrators as to receivers. The second development has been the growth and increasing importance of international insolvency litigation. This development is reflected in the vastly expanded treatment in this edition of the Conflict of Laws, the European Union Regulation on Insolvency Proceedings and the UNCITRAL Model Law recently incorporated into United Kingdom Law.

To help us meet the challenges of the new edition we have required and obtained the expertise and commitment to the project of three managing editors, Richard Snowden QC, Professor Ian Fletcher and Mr Hamish Anderson and contributions (large and small) to individual chapters as indicated in the subsequent List of Contributors.
