THIRD CIRCUIT.

Comprising Delaware, New Jersey, and Pennsylvania.

JUSTICE OWEN J. ROBERTS, of Pennsylvania. Appointed May 20, 1930, by President Hoover.

FOURTH CIRCUIT.

Comprising Maryland, North Carolina, South Carolina, Virginia, and West Virginia.

CHIEF JUSTICE CHARLES EVANS HUGHES, of New York. Appointed February 13, 1930, by President Hoover.

FIFTH CIRCUIT.

Comprising Alabama, Florida, Georgia, Louisiana, Mississippi, Texas, and Canal Zone.
