Preface

WHEN I first began to study European Community law, at about the time when the United Kingdom became a member of the Community, I gained the initial and no doubt shallow impression that here was a branch of law which was exciting, dynamic, intriguing, perplexing, and sometimes chaotic (in that order). It seemed to me that there was a need, shared by practitioners and students alike, for a book devoted solely to the basic freedoms upon which the substantive law of the European Community was so largely based, and to which so much of the litigation in the European Court had been devoted. This is such a book. Its preparation has, I hope, brought me to a deeper understanding of the subject. Today I can express the more confident and mature opinion that this field of law is exciting, dynamic, intriguing, perplexing, and sometimes chaotic (in that order).

Assiduous readers of literature on Community law will no doubt recognize Chapter 3 (State Monopolies) as an expanded version of my article on the same subject in volume 3 of the *Yearbook of European Law* (1984).

I am deeply indebted to all those who have offered encouragement, and to the successive secretaries who have with unfailing patience prepared the typescript. In particular I should like to thank my colleague Joanne Foakes for having prepared the index.

To the best of my information, belief, and understanding the law is stated as it was on 1 January 1985.
