## Preface

It is now five years since the publication of the first edition of this book. Despite the fact that conflict of laws is only an optional subject in most Australian law schools the first edition sold well and a second edition has been called for. The opportunity has been taken to thoroughly revise the book and change its arrangement. In addition to the obvious inclusion of new cases and legislation the main changes are (1) the rearrangement of the chapters and their grouping into larger Parts (2) the inclusion of new chapters on quasi-contracts, currency questions, trusts, and arbitration (3) the incorporation of the material on matrimonial law from Pyles, *Conflicts in Matrimonial Law* (Butterworths, 1975) and (4) the reduction of the digests (being summaries of cases not fully reproduced) and their reproduction together with questions and comments in the form of Notes following leading cases and statutes.

As in the case of the first edition, for reasons of space, it has not proved possible to include cases on the topics of infants and legitimacy and on the sub-topics of powers of appointment in the field of succession.

The greater bulk of the material in this edition has been contributed by Dr Pyles. Professor Sykes, by reason of the magnitude of his commitment to other projects at the time, was unable to consider approaching this work on the basis of an equal division of topics. It was therefore agreed between the two contributors that Professor Sykes confine his direct contribution to the property aspects of the subject. The result is that the division of topics is as follows: Dr Pyles is responsible for Parts I-V (Chapters 1-18) and Parts VII-VIII (Chapters 24-27) whilst Professor Sykes is responsible for Part VI (Chapters 19-23). Both authors were concerned in the planning involved in the changes effected by the present edition.

The manuscript was completed in March 1980 and the cases, legislation and secondary materials were selected as at that time.
