# 总 序

吴志攀

加入世界贸易组织表明我国经济发展进入了一个新的发展时代——一个国际化商业时代。商业与法律的人才流动将全球化，评介人才标准将国际化，教育必须与世界发展同步。商业社会早已被马克思描绘成为一架复杂与精巧的机器，维持这架机器运行的是法律。法律不仅仅是关于道德与公理的原则，也不单单是说理论道的公平教义，还是具有可操作性的精细的具体专业技术。像医学专业一样，这些专业知识与经验是从无数的案例实践积累而成的。这些经验与知识体现在法学院的教材里。中信出版社出版的这套美国法学院教材为读者展现了这一点。

# Preface

The book is premised on the view that tort law is more than a collection of doctrines and policies, and that it cannot realistically be understood apart from the processes by which tort disputes are resolved. It is as important for students to grasp the roles of the lawyer, the trial judge, the jury, and the appellate court in resolving a tort claim as it is to understand the doctrinal and policy elements that are at play. We find that providing students with this process perspective greatly enhances their appreciation for the actual nature, functions, and limits of tort law. To aid this effort to study tort law in motion, the book includes a series of problems that challenge students to apply their doctrinal understanding to concrete circumstances. We have found that students, even in their first weeks of law study, benefit significantly from the effort and find it interesting and rewarding. There is no need, however, to assign all, or indeed any, of the problems, for the book is also designed to function as a traditional casebook. Finally, the book seeks to enrich and broaden students' understanding by providing integrated discussions of tort theory and policy issues and by raising important ethical considerations.

We have made a few structural changes in this sixth edition. We have moved "Offensive Battery" from Chapter 10 to Chapter 1. Understanding the offensive battery concept is essential to understanding liability for harmful battery, so we placed offensive battery early in the book, where it can be dealt with directly. We have also replaced Problem 1 with a new problem that we think is more teachable. We deleted the subject of constitutional torts from Chapter 10. We feel that this is too complex a topic to be dealt with, even in a cursory fashion, in the basic Torts course. A new Restatement (Third) Torts: Apportionment of Liability has been adopted by the American Law Institute. We have referred to and quoted from this new Restatement at several places. The years since the fifth edition have produced several important cases involving the Restatement (Third) Torts: Products Liability, which we have included. In the end, however, this edition retains its original flavor. Those who have used the earlier editions will find this edition comfortably familiar.
