Notes on the Contributors

Preet S. Aulakh is Associate Professor in the Fox School of Business and Management at Temple University. He received his PhD from the University of Texas at Austin and BS (Mathematics) and MA (History) degrees from Panjab University, Chandigarh, India and previously taught at Eli Broad College of Business at Michigan State University. His research on foreign entry modes, international marketing strategy and performance, cross-national strategic alliances, liberalization in emerging markets, and technology transfers has been published in such journals as the *Journal of International Business Studies*, *Journal of Marketing*, *Journal of International Marketing*, and *Revista de Administracao de Empresas*.

Peter Dorman teaches at Evergreen State University in Olympia, Washington. He is an economist (PhD University of Massachusetts) whose interests include safety and environmental regulation, the role of labour standards in international trade, and the interaction between markets and institutions. He is the author of *Markets and Mortality: Economics, Dangerous Work, and the Value of Human Life* (Cambridge University, 1996), as well as many journal articles and book chapters. He has served on an US National Academy of Sciences/National Research Council study of child labour and is a member of the European Network on Industrial Policy. He is the chief administrator of a global network of scholars, GTNet (Global Transformation Network).

Jan Aart Scholte is a senior lecturer in International Relations at the University of Warwick (England). After earning his doctorate at the University of Sussex, he taught both at Sussex and at the Institute

of Social Science in The Hague, Netherlands. He is the author of many articles and chapters of books on international political economy, political development of Indonesia, the International Monetary Fund, and globalization. In addition to several works on South African and Lake Victoria environment, his publications include: *Southern Africa: Society, Economy and Liberation* (Michigan State University, 1980); *Group Portrait: International Education in the Academic Disciplines* (The American Forum, 1990); *Academic Analysis and US Foreign Policy-Making on Africa* (Michigan State University, 1991); *The Third World: Africa* (Dushkin, 1984); and *Africa on Film and Videotape* (African Studies Center, Michigan State University, 1982). He is editor of the quarterly journal *African Rural and Urban Studies*.

Jiawen Yang is an Assistant Professor of International Business for the School of Business and Public Management at the George Washington University in Washington, DC. Prior to joining the George Washington faculty, he was a Visiting Assistant Professor of Finance at the Owen Graduate School of Management, Vanderbilt University. Dr Yang received his doctorate degree from the Stern School of Business, New York University, where he also taught a variety of courses in international economics and finance. In addition, he has served on the faculty at the General Electric Management Development Institute, the Asian-Pacific Commercial Training Center in Beijing, and the University of International Business and Economics, also in Beijing.
