FOREWORD

It may be that all languages require and develop conventional abbreviations and the use of recognised initial letters.

Certainly Latin is a good example: many a stonemason must have been glad that the economy of SPQR could go a long way to offset the inconvenience of Roman numerals.

Lawyers, however, seem to have acquired an especial taste for abbreviations and acronyms which they use to draw attention to case reports and other legal works. The practice is convenient but in the past it has been the cause of much frustration and time-consuming research.

It was to meet a long-felt need that Donald Raistrick came forward in 1981 with the first edition of his *Index to Legal Citations and Abbreviations*.

Since then on countless occasions lawyers and other readers of legal literature have had good reason to feel grateful for the existence of this work and to admire the skill and industry of its author. A particularly valuable feature of the *Index* is the fact that it includes variants of citations as well as the standard form.

In his Foreword to the first edition of the Index Wallace Breem forecast that it would be found to be 'an invaluable bibliographical tool'. So it has proved. But the introduction of fresh series of law reports and further discoveries by Donald Raistrick have prompted calls for a new edition.

I have no doubt that the second and expanded edition of the Index will place us all even further in the author's debt.

PREFACE

This is the age of the abbreviation and acronym, but in few fields are they more abundant or do they have a longer history than in law. Identifying abbreviations has long been a problem for lawyers and for others using the literature: legal citations span centuries. Authors of books, articles and reports frequently assume that their readers will automatically be able to decipher whatever form of abbreviation is used. There is no standardisation; different people have preferences for different forms, and many abbreviations have more than one meaning.

This index therefore reflects usage. It is not a guide to recommended forms of citation or abbreviation since the unfavoured and incorrect are also included. This second edition has been increased in size to include more than 25,000 entries, from abbreviations with a single meaning to those with more than twenty. The geographical coverage is broader than before. Though the major source of entries is still the United Kingdom and Ireland, the Commonwealth and the USA, the index includes many more entries than before from member countries of the European Communities, from other European countries and also from Africa, Asia and South America. The country of origin, if not England or UK, is indicated unless it is obvious from the title.

The alphabetical arrangement is firstly by single initial letters and subsequently by groups of letters or part-words with the same initial letter. For example, under the letter A, all abbreviations that commence with that letter alone, before a full stop or another capital letter (A.A., A.B.A., A.L.T., ASAL), precede those headed by A forming a part-word (Ab., Acq., Ala., etc.). Where the ampersand appears, that abbreviation is arranged at the end of the sequence of the letter or part-word preceding the ampersand (A.B., A.F., A.Z., A.& B., A.& G., etc. Al., Al.Ser., Al.& N., Al.& Nap., etc.). This arrangement, which is basically a word-by-word approach, has the benefit of grouping together abbreviations with the same root, that would be separated if a strict letter by letter style was adopted. In general, abbreviations headed by a lower case letter precede the same letters in capital form, and those without full stops precede those with.


Preface

I have in most cases given the dates for law report and journal titles. For reports series appearing in the *English Reports*, I have indicated the volume numbers, e.g. 110–3 ER. Those that can be found in the *Revised Reports* show the volume numbers of that series, e.g. 50 RR. Similarly, I have found it possible to include references to some American reports series, e.g. 1–4 U.S., 13 S.C.Eq. Any abbreviations used in the entries in this book are themselves indexed.

In the twelve years that have passed since the publication of the first edition of *Index to Legal Citations and Abbreviations*, many new journals and series of law reports have appeared. I commend the practice of many publishers of printing, in each issue, the approved method of citation for their publication. I hope that many more publishers will follow that example and that those quoting such publications will use the official citation.

I am indebted to many people for the great number of helpful suggestions and comments that I have received over the years. I am, however, particularly grateful to Maureen McCormick, Executive Director of the British Columbia Law Library Society, and Colin Fong. Manager of Library Services at Allen Allen & Hemsley, Sydney, for the invaluable lists of Canadian and Australian abbreviations that they sent to me, and to John Rees, of John Rees Rare Books, who allowed me access to his warehouse, where I was able to check for abbreviations used in a vast range of publications from all over the world. In the preparation and checking of my database, I received a tremendous amount of help, for which I am very grateful, from three people in particular. None of the data from the first edition was held on computer and Sandra Naylor spent many hours helping me to add this material to the database and checking its accuracy. All the entries that I prepared were checked by Paula Nyunt. Stuart Cole also added some of the entries, checked the entire computer printout and corrected some of the page proofs. Without the assistance, so readily given by Paula, Sandra and Stuart, I would not have been able to meet my deadlines. My thanks are also due to Lord Justice Neill for writing the Foreword to this volume, to Fleur and Mark for their understanding, and to Michael Chapman, formerly of Bowker-Saur who secured the editorial board's approval, and Margaret Little, who saw the work through to publication.
