

#### Preface

Ask any American his or her view of the justice system and you will receive a lengthy, passionate answer deeply rooted in that person's social, political, and legal experience. For those pursuing careers as legal professionals, *Basic Criminal Law*, third edition, provides a comprehensive, organized approach to understanding key legal concepts and to developing real-world skills students will need when they enter the workforce.

#### Third Edition Tools

Like the second edition, the third edition uses a "crimes first, procedure second" approach to criminal law. We have retained and updated the popular "You Make the Call" sections to spur lively classroom discussions. Additionally, we have also revised the "Historical Highlights" that appear throughout the book. These highlights illustrate pivotal events in American legal history, events that remain influential today and continue to inform legal and public debate. The "highlights" provide students with a historical context and provide a legal cultural literacy necessary for legal professionals to succeed.

The third edition contains many new additions to enhance both the teaching and learning experience, including:
