Notes on contributors

Hugh Adlington

Dr Hugh Adlington is Lecturer in English at the University of Birmingham. He has published numerous journal articles and book chapters on early modern literature, religion, law, and politics. He is a volume editor of the *Oxford Edition of the Sermons of John Donne* (forthcoming), and co-editor of the *Oxford Handbook of the Early Modern Sermon* (forthcoming).

Jayne Elisabeth Archer

Dr Jayne Elisabeth Archer is Lecturer in Medieval and Renaissance Literature in the Department of English and Creative Writing at Aberystwyth University. She is an Associate Fellow of the Centre for the Study of the Renaissance, University of Warwick. She is General Editor of *John Nichols's The Progresses and Public Processions of Queen Elizabeth I: A New Edition of the Early Modern Sources* (Oxford University Press, forthcoming) and co-editor of an essay collection: *The Progresses, Pageants, and Entertainments of Queen Elizabeth I* (Oxford University Press, 2007). She has published articles on Elizabethan and Jacobean masques, early modern women's receipt books, and alchemy in early modern literature, and is currently working on a book-length study of the relationship between housewifery and natural philosophy in early modern England.

J. H. Baker

Sir John Baker, QC, is Downing Professor of the Laws of England at the University of Cambridge and Professorial Fellow of St Catharine's College. A member of both the Inner Temple and Gray's Inn, he is an Honorary Bencher of the Inner Temple and Literary Director of the Selden Society. Sir John is the leading expert on early modern English legal history, with a particular interest in the history of the legal profession and of the Inns of Court in this period. His many publications include *An Introduction to English Legal History* (Butterworths, 1971; 4th edn 2002), *The Legal Profession and the Common Law* (Hambledon Press, 1986), *Readings and Moots at the Inns of Court in the Fifteenth Century* (with Samuel E. Thorne; Selden Society, 1990), and *The Law's Two Bodies: Some Evidential Problems in English Legal History* (Oxford University Press, 2001). He is also General Editor of the multi-volume

Oxford History of the Laws of England (Oxford University Press, 2003–), as well as the author of volume six of that series, which covers the period 1483–1558.

Tarnya Cooper

Dr Tarnya Cooper, Sixteenth-Century curator at the National Portrait Gallery, was sole curator for the 2006 exhibition *Searching for Shakespeare* and edited the exhibition catalogue of the same name. In 2003, she was co-curator of the National Maritime Museum's *Elizabeth* exhibition and contributed to the accompanying exhibition catalogue. An expert on Tudor portraiture and specifically portraits of the professional classes in early modern England, Dr Cooper is currently completing a book entitled *Citizen Portraiture: Portrait Painting and the Urban Elite in Tudor and Jacobean England and Wales*.

Bradin Cormack

Bradin Cormack is Associate Professor in the English Department at the University of Chicago and Director of the Nicholson Center for British Studies there. His publications include *A Power to do Justice: Jurisdiction, English Literature, and the Rise of Common Law, 1509–1625* (University of Chicago Press, 2007) and *The Forms of Renaissance Thought: New Essays on Literature and Culture*, co-edited with Leonard Barkan and Sean Keilen (Palgrave Macmillan, 2008). He is currently at work on two books, a study of Shakespeare's sonnets and a monograph on *Shakespeare and Law*.

Mark Girouard

Dr Mark Girouard, formerly Slade Professor of Fine Art at Oxford University (1975–76) and George Lurcy Visiting Professor at Columbia University (1987), is the leading historian of English architecture of his generation. A member of the Royal Fine Art Commission (1972–96) and the Royal Commission on Historical Monuments (1976–81), he is the author of numerous books, including *Robert Smythson and the Architecture of the Elizabethan Era* (Country Life, 1963; published in a revised form as *Robert Smythson and the Elizabethan Country House* by Yale University Press, 1983) and *Life in the English Country House* (Yale University Press, 1978), the latter of which won the Duff Cooper Memorial Prize as well as the W. H. Smith Award for 1979. His *Elizabethan Architecture: Its Rise and Fall, 1540–1640* was published by Yale University Press/The Paul Mellon Centre for Studies in British Art in 2009.

Elizabeth Goldring

Dr Elizabeth Goldring is an Associate Fellow of the University of Warwick's Centre for the Study of the Renaissance and a Consultant to English Heritage. Her research interests encompass sixteenth- and seventeenth-century court culture, England and the Continental Renaissance, and relations between literature and the visual arts. Publications include: (General Editor) *John Nichols's The Progresses and Public Processions of Queen Elizabeth I: A New Edition of the Early Modern Sources* (Oxford University Press, forthcoming); (co-editor) *The Progresses, Pageants, and*

Entertainments of Queen Elizabeth I (Oxford University Press, 2007); (Associate General Editor) *Europa Triumphans: Court and Civic Festivals in Early Modern Europe* (Ashgate, 2004); and (co-editor) *Court Festivals of the European Renaissance: Art, Politics and Performance* (Ashgate, 2002). She has also published articles in journals such as *ELR: English Literary Renaissance*, *The Burlington Magazine*, [The] *British Art Journal*, and *English Heritage Historical Review*. Current projects include a book on painting and patronage at the Elizabethan court.

Paula Henderson

Dr Paula Henderson is an independent scholar who specialises in early modern architectural and garden history. Her many publications include articles in *Garden History*, *Architectural History*, and *Country Life*, as well as essays in Lucy Gent (ed.), *Albion's Classicism: The Visual Arts in Britain, 1550–1660* (Yale University Press, 1995) and in Pauline Croft (ed.), *Patronage, Culture and Power: The Early Cecils, 1558–1612* (Yale University Press, 2002). Her first book, *The Tudor House and Garden: Architecture and Landscape in the Sixteenth and Early Seventeenth Centuries* (Yale University Press, 2005), won the Berger Prize for British Art History.

Lorna Hutson

Lorna Hutson is Berry Professor of English Literature and Head of the School of English at the University of St Andrews. She is co-editor (with Victoria Kahn) of *Rhetoric and Law in Early Modern Europe* (Yale University Press, 2001) and has recently edited a special forum of *Representations* on Ernst Kantorowicz entitled 'Fifty Years of *The King's Two Bodies*' (vol. 106, Spring 2009). Her most recent book, *The Invention of Suspicion: Law and Mimesis in Shakespeare and Renaissance Drama* (Oxford University Press, 2007) won the Roland H. Bainton Prize for Literature in 2008.

Sarah Knight

Dr Sarah Knight is Senior Lecturer in Shakespeare and Renaissance Literature, School of English, University of Leicester. Her main research and teaching interests are in early modern English and Latin literature, and in the intellectual and literary culture of the English universities during the sixteenth and early seventeenth centuries; she is particularly interested in academic drama, representations of adolescence, and the relationship between satire and education. She has edited and translated Leon Battista Alberti's *Momus* and the accounts of Elizabeth I's visits to Oxford in 1566 and 1592 for the new edition of John Nichols's *Progresses*, and is preparing an edition and translation of John Milton's *Prolusions*, and new editions of the plays of Fulke Greville and the college play *The New Moone*.

Richard McCoy

Richard McCoy is Professor of English, Queens College and Graduate Center, CUNY. His publications include *Alterations of State: Sacred Kingship in the English Reformation* (Columbia University Press, 2002), *The Rites of Knighthood: The Literature and Politics of Elizabethan Chivalry* (University of California Press, 1989),

and *Sir Philip Sidney: Rebellion in Arcadia* (Rutgers University Press, 1979). He is currently working on *Faith in Shakespeare: Theology and Performance*, a study of links between Reformation liturgical theology and contemporary performance theory in early modern drama. He has published many articles in journals such as *Shakespeare Survey*, *Criticism*, the *Historical Journal*, and the *Journal of Medieval and Renaissance Studies*.

Alan H. Nelson

Alan H. Nelson is Professor Emeritus in the Department of English at the University of California, Berkeley. His specialisations are palaeography, bibliography, and the reconstruction of the literary life and times of medieval and Renaissance England from documentary sources. His most recent publication is *Monstrous Adversary: The Life of Edward de Vere, Seventeenth Earl of Oxford* (Liverpool University Press, 2003). He is one of the four editors of *Records of Early English Drama: Oxford*, 2 vols (University of Toronto Press, 2004). Professor Nelson is currently working on *London: Inns of Court*, also for REED. His monograph, *The Library of Humphrey Dyson*, is forthcoming from the Oxford Bibliographical Society.

Damian X. Powell

Dr Damian X. Powell is Principal of Janet Clarke Hall and a Senior Fellow in the School of Historical Studies within The University of Melbourne. He writes on aspects of British and Australian legal and military history. Previous publications include 'Remembrance Day: Memories and Values in Australia since 1918', *Victorian Historical Journal* (2004), 'Coke in Context: Personal and Professional Observation in Sir Edward Coke's Reports', *Journal of Legal History* (2000), and *James White Locke's Liber Famelicus, 1570–1632: Law and Politics in Early Stuart England* (P. Lang, 2000).

Wilfrid R. Prest

Professor Emeritus in History and Law at the University of Adelaide, Wilfrid Prest is the author of *The Inns of Court under Elizabeth I and the Earl Stuarts, 1590–1640* (Longman, 1972), *The Rise of the Barristers: A Social History of the English Bar, 1590–1640* (Clarendon Press, 1986), *Albion Ascendant: English History, 1660–1815* (Oxford University Press, 1998), and most recently *William Blackstone: Law and Letters in the Eighteenth Century* (Oxford University Press, 2008), together with articles and chapters on law, the legal profession, the Inns of Court, and aspects of religious, social, and political history in early modern Britain, circa 1550–1800.

Paul Raffield

Dr Paul Raffield is Associate Professor in the School of Law, University of Warwick, and a member of Gray's Inn. He is the author of a monograph, *Images and Cultures of Law in Early Modern England: Justice and Political Power, 1558–1660* (Cambridge University Press, 2004) and has published articles on various aspects of the relationship between law and literature in early modern England, in *Law and Literature*

(2009, 2005), *Law and Critique* (2002, 1997), *International Journal for the Semiotics of Law* (2000), and *Journal of Legal History* (1999). In 2007, he co-organised a conference on 'Shakespeare and the Law', hosted by The University of Warwick, papers from which were published in an edited collection: Paul Raffield and Gary Watt (eds), *Shakespeare and the Law* (Hart Publishing, 2008). He is currently writing a monograph, *Shakespeare's Imaginary Constitution: Late-Elizabethan Politics and the Law*, to be published by Hart in 2010.

Emma Rhatigan

Dr Emma Rhatigan is currently a lecturer at Sheffield University. Her 2006 DPhil dissertation explored John Donne's Lincoln's Inn sermons, tracing the history of preaching at Lincoln's Inn, and examining how the sermons Donne preached in the pulpit can be interpreted in terms of his intimate relationship with the Society. She is currently adapting her thesis into a book-length study of preaching at Lincoln's Inn between 1580 and 1642 and in conjunction with this work is editing a volume of Donne's Inns of Court sermons for the recently commissioned *Oxford Edition of the Sermons of John Donne*. She is also editing, with Hugh Adlington and Peter McCullough, *The Oxford Handbook to the Early Modern Sermon*. Her publications include essays in *John Donne Journal* (2004), *Journal of Ecclesiastical Studies* (forthcoming), and *The Oxford Handbook of John Donne Studies* (forthcoming).

Geoffrey Tyack

Dr Geoffrey Tyack is a Fellow of Kellogg College, Oxford, Director of the Stanford University Centre in Oxford, editor of the *Georgian Group Journal*, and a Fellow of the Society of Antiquaries. He has published widely on English architectural history and is an expert on the collegiate architecture of Oxford and Cambridge. His many publications include *Sir James Pennethorne and the Making of Victorian London* (Cambridge University Press, 1992), *Oxford: An Architectural Guide* (Oxford University Press, 1998), and *Modern Architecture in an Oxford College: St John's College, 1945–2005* (Oxford University Press, 2005). He has recently contributed a chapter on William Dugdale and the Warwickshire country house to C. Dyer and C. Richardson (eds), *William Dugdale, Historian, 1605–1686* (Boydell Press, 2009), and his revision of the Berkshire volume in the Pevsner *Buildings of England* series was published by Yale University Press in 2010.
