He is involved in several programs in which local decision makers are trained in the use of impact assessment and policy evaluation tools. Dr. Johnson is on the Advisory Committee of American Runs on Local Roads, the Editorial Board of the *Southern Journal of Agricultural Economics*, and the Executive Council of the Southern Regional Science Association.

**Lonnie Lee Jones** is a Professor of agricultural economics at Texas A&M University and a co-owner of Southwest Resources Analysts, a consulting firm specializing in research and educational services in resource economics

and impact analyses. Dr. Jones was a recipient of a grant from the AAEA to participate in the Fourteenth International Conference of Agricultural Economists at Minsk, Russia, in August 1970, and was selected as the Researcher of the Year--Department of Agricultural Economics, 1976-77. He is also affiliated with several Agricultural Economics Associations. His more active research involves studying the economic impacts of industrialization in rural communities, and economics of institutional arrangements for viable rural communities in Texas. **Marvin Konyha** joined the Florida Cooperative Extension Service in 1970. He then came to the Extension Service, USDA, in 1973 as Program Leader, Manpower Development and Community Facilities on the Community and Rural Development staff. He served three years as Program Coordinator, Community and Rural Development, on the Joint Planning and Evaluation Staff of the USDA, Science and Education Administration, and completed the USDA Senior Executive Service Candidate Development Program, September, 1982. **Warren Kriesel** received a B.Sc from the University of Wisconsin, River Falls in 1977 and his MSc degree in Agricultural Economics from Virginia Polytechnic Institute and State University. After completing the MSc degree, he was employed as a Research Assistant by the University of Kentucky. He is currently a Ph.D. candidate at Ohio State University. He has served as a Peace Corps volunteer in Malaysia. His research interests include the process and determinants of economic development, regional planning, and resource economics policy.

**F. Larry Leistritz** is Professor of Agricultural Economics at North Dakota State University at Fargo. He has completed extensive research regarding the economic and fiscal impacts of energy resource development in the western United States. From 1975 to 1978, he served as Associate Director of the North Dakota Regional Environmental Assessment Program, a state-funded research and policy analysis project for analyzing the impacts of energy development. In that capacity he was responsible for managing the development of the REAP Economic-Demographic

Models, RED-1 and RED-2. He is senior author of *Socioeconomic Impact of Resource Development: Methods for Assessment* (Westview Press), *Social Impact Assessment and Management: A Bibliography* (Garland Publishing), and *Interdependencies of Agriculture and Rural Communities: an Annotated Bibliography* (Garland Publishing), and coauthor of four other books. In 1978-79 he was a Visiting Professor of Agricultural Economics at Texas A&M University, where he advised in the development of the Texas Assessment Modeling System (TAMS). He received his Ph.D. in agricultural economics from the University of Nebraska--Lincoln in 1970.

George McDowell is a Professor of Agricultural Economics at Virginia Polytechnic Institute and State University and an on assignment in Zambia. At the time of the preparation of this chapter he was an Associate Professor of Agricultural and Resource Economics and an Extension Economist at the University of Massachusetts. Dr. McDowell's special focus is on problems of local government finance and financial management, the role that local governments hold in rural development, and the political economy of extension and research in Land Grant Universities. **Daniel M. Otto** is an Associate Professor of Economics and an Extension Economist at the Iowa State University. His areas of specialty include Community and Rural Development, Impact Analysis, and Economic Feasibility Analysis of Public Services and Facilities. He has written numerous articles in related areas, and is currently actively involved, at both the community and state level, with various community development workshops and analyses. He is currently developing various data bases, economic forecasts, and input-output models for the State of Iowa. Dr. Otto received a B.A. in Economics and a M.S. in Agricultural Economics from the University of Minnesota, and a Ph.D. in Agricultural Economics from Virginia Tech.

**Glen C. Pulver** is Professor of Agricultural Economics at the University of Wisconsin-Madison. He holds M.S. and Ph.D. degrees from that same University. He first joined the faculty of the Department of Agricultural Economics at the University of Wisconsin in 1955. His field of specialty is Community Economic Development. In this role he works closely with governmental bodies, economic development committees, organizations, agencies, and educators throughout Wisconsin. His research is focused on community economic development policy and capital acquisition for new and developing businesses. Dr. Pulver also has previous experience as a visiting professor in southern Brazil and Indonesia, as dean of the University of Wisconsin-Extension, and as associate director of the Cooperative Extension Service at Purdue University. He has extensive work experience both in rural and urban settings. He is a past president of the Community Development Society of America and the recipient of its Distinguished Service Award in 1986.

**J. Norman Reid** is currently chief of the Rural Business and Government Branch, ERS, USDA. He directs a program of research on rural economic and governmental trends and their public policy implications. He has written on rural public infrastructure, rural economic and social trends, entrepreneurship, rural development policy, federal aid to rural areas, and substate regionalism. Dr. Reid received his B.A. in political science from Muskingum College in Ohio in 1967, his A.M. in political science from the University of Missouri, Columbia, in 1969, and his Ph.D. in political science from the University of Illinois, Urbana, in 1975. Before assuming his current position he headed the State and Local Government Section of ERS.

**Eduardo Segarra** is an Assistant Professor of Agricultural Economics at Texas Tech University. Dr. Segarra earned his M.S. at the University of Missouri and his Ph.D. at Virginia Polytechnic Institute and State University. His research interest include resource economics and conservation, and the use of mathematical programming models.

**Ron E. Shaffer** is a Professor of Agricultural Economics and Community Development Economist at the University of Wisconsin-Madison. Dr. Shaffer's extension responsibilities include working with community groups to build economic development strategies and understand local and nonlocal forces affecting community economic development. Part of this effort includes the development (with Dr. Glen Pulver) of a micro computer system for community economic analysis. His research is on the local economic impacts of economic development, sources of employment change, identifying types of economic development most likely to employ specific workers, the influence commercial bank policies play in local economic development, and sources and uses of capital for new small businesses. He serves as an advisor to the State of Wisconsin on economic development policies and chaired a national task force preparing a report for Extension USDA on economic development impacts and rural data needs. He developed a methodology to evaluate the community impact of economics development that has been used in Florida, Indiana, Kansas, Michigan, Minnesota, Ohio, Oklahoma, South Dakota, Texas, Virginia and Wisconsin. He has taught impact evaluation at the American Economic Development Council's Basic Industrial Development Seminar. He works with the Organization for Economic and Cooperative Development (DECD) in Paris, France on local economic development strategies. During 1980-81, he was a visiting professor to the Institute of Industrial Economics, Bergen, Norway. In 1985, Ron and Glen Pulver were recognized with the Outstanding Extension Program Award by the American Agricultural Economics Association.

**Thomas F. Stinson** is a Professor in the Department of Agricultural and Applied Economics at the University of Minnesota. Specializing in rural economic development issues, his current research includes a study of the restructuring of the rural economy, a study of the effect that two decades of changes in the federal system have had on local government finances in non-metropolitan communities, and an assessment of rural infrastructure needs based on a national survey of rural communities sponsored by USDA's Farmers Home Administration. Most recently, he completed a major report, *Governing the Heartlands: Can Rural Communities Survive the Farm Crisis*, for the U.S. Senate's Subcommittee on Intergovernmental Relations. Dr. Stinson received a Ph.D. in Economics from the University of Minnesota. Before joining the faculty at the University of Minnesota,

Dr. Stinson was employed by the U.S. Department of Agriculture's Economic Research Service for more than 20 years.

**Patrick J. Sullivan** is chief of the Finance and Tax Branch, in the U.S. Department of Agriculture's Economic Research Service. Previously, he worked in the State and Local Government Section and supervised the Financial Markets Section of ERS. Before joining the USDA in 1977, he completed undergraduate and graduate work in economics at Syracuse University and taught economics at the State University of New York College at Oswego. He has written extensively about rural development, public finance, local infrastructure, and financial economics issues. He is a member of the editorial board of the *State and Local Government Review*. In his current position, he directs and conducts research on the impacts of Federal tax policies, credit programs, and financial deregulation on the agricultural sector and rural economies.

**Bruce A. Weber** is a Professor and Extension Economist in the Department of Agricultural and Resource Economics at Oregon State University.
