PREFACE

THE aim of the third edition of this book remains the same: to help those students of contract who do not have access to an adequate or to any law library, and those university students who want materials for a straightforward introduction to the subject which will also be of use for revision.

Probably the greatest change to take place in the development of the law of contract in recent years has been the enactment of the Unfair Contract Terms Act 1977. This is reflected in the book: the most important provisions of that statute, with explanatory notes, appear in their appropriate places.

Some cases—but I hope not too many—have had to be removed to make room for more recent judicial decisions.

In the result over 345 cases are treated and nearly 40 extracts from (or notes on) statutes are provided.
