PREFACE

The third edition of this casebook (itself a successor to a volume with fewer authors) aims to build on the strengths of its predecessors. Specifically, we have continued to emphasize intellectual challenge. To that end, we have chosen main cases that raise difficult issues on interesting facts and supplemented those cases with extensive notes. What is new about this edition is neither the ambition nor the style but rather the execution. In ways large and small, we have revised and refined these materials in light of our classroom experience. The most noticeable such change is a new Chapter III entitled “Mens Rea: Illustrations from Federal Law.” This chapter presents optional materials on difficult mens rea issues from federal law and allows simplification and shortening of the preceding chapter on “The Criminal Mind.” We think “teachability” is thereby improved.

In addition to revisions based on teaching experience, we have also updated our treatment of many subjects, especially those involving social science information. Our aim has been to combine intellectual sophistication with the clarity and accessibility that sustain use of a book in the classroom. We hope we have succeeded in that ambition and invite users (and others) to let us know where we have not.
