PREFACE

This is the fourth edition of a work first published in 1977 under the joint authorship of myself, Charles Cross and Jack Garner. The second and third editions were jointly produced by myself, Brian Jones and Alastair Mowbray. Unfortunately, neither Brian nor Alastair was available for this edition, for which I am solely responsible.

The period since the third edition appeared, in 1997, has coincided with the term in office (to date) of a Labour Government that has been committed to reforms (fundamental and otherwise) across the public sector and in the legal system. Much of interest has happened in and out of the courts. This edition has expanded by comparison with its predecessor for a number of reasons. First, the enactment of the Human Rights Act 1998 has introduced a new dimension to the legal system, with new constraints on the decisions and acts of public bodies. This is dealt with in a new separate chapter. Secondly, the opportunity has been taken to expand the coverage by way of commentary and notes, recognised in the change of title. Thirdly, there have been important areas that have seen significant and ongoing developments, including the codes of practice and conduct concerning decision making in the public sector, and the law concerning duties, the scope of review for error of fact, delegation, estoppel, irrationality, unjustified inconsistency (interference with substantive legitimate expectations) and lack of proportionality, bias and interest, appeals, the procedure for judicial review and civil liability. All this has necessitated much restructuring and rewriting.

I am grateful to the University of Nottingham for a year's study leave, following a six year term as a Pro-Vice-Chancellor, to the publishers for their help and support, to Fiona Hayes and Claire Jennings who typed a large amount of material, and to Brian Jones who contributed comments at the proof stage.

The manuscript was submitted in May 2005, and some more recent developments have been noted.
