Sanda Rodgers is a Full Professor and the former Dean of the Faculty of Law, University of Ottawa. She has been a Bencher of the Law Society of Upper Canada and Commissioner of the Ontario Law Reform Commission, and is a recipient of the Women Lawyers Association President's Award for Outstanding Contribution to the Legal Profession and of the Business and Professional Women's Association of Ottawa Women's Choice Award for Outstanding Contributor to Gender Equity. She previously held the Shirley Greenberg Professorship in Women and the Legal Profession. Her primary area of research is in the area of health law, with particular emphasis on women's reproductive rights.

Sheila McIntyre

Jennie Abell, B.A., LL.B., LL.M., is an Associate Professor in the Faculty of Law, University of Ottawa. Her teaching subjects have included Criminal Law and Procedure, Poverty and the Law, Women and Human Rights: Global Perspectives, and Women and Justice. Jane Bailey is an Associate Professor at the University of Ottawa, Faculty of Law, Common Law Section. She holds an LL.M. from the University of Toronto, an LL.B. and M.I.R. from Queen's University, and a Bachelor of Administrative Studies (Honours) from Trent University. Prior to coming to the University of Ottawa, Professor Bailey practised civil litigation with Torys LLP. She assisted as co-counsel for the complainant Sabina Citron in the first Canadian human rights case involving the regulation of Internet hate speech. Before beginning legal practice, she was a law clerk to Mr. Justice Sopinka of the Supreme Court of Canada. Her current research interests centre on the impact of emerging communications technologies on equality-seeking communities. She has spoken and written widely on Internet hate speech and online child pornography, including publications on the privacy interests affected by hate speech, child pornography and obscenity.

Nathalie J. Chalifour — The Pursuit of Environmental Justice in the McLachlin Court

Nathalie Chalifour is an Associate Professor at the Faculty of Law, University of Ottawa. Her main area of research is environmental law and policy, with a focus on the intersection between the environment, social justice and the economy. She is the co-editor of *Critical Issues in Environmental Taxation, Volume V* (2008), *Land Use Law for Sustainable Development* (2007), and *The Canadian Brownfields Manual* (2004). Her publications address a variety of topics, including the impact of environmental policies on marginalized groups, climate justice, ecological fiscal reform and sustainable forestry. Prior to joining the Law Faculty, Nathalie was senior advisor to the President of the National Round Table on the Environment and the Economy. She also worked for World Wildlife Fund and taught at the University of Nairobi, Kenya. She obtained her Doctorate of Law at Stanford University, and holds a Master in Juridical Sciences which she obtained as a Stanford Program in International Legal Studies Fellow and Fulbright Scholar.

Larry Chartrand — The Story in Aboriginal Law and Aboriginal Law in the Story: A Métis Professor's Journey

Larry Chartrand, B.Ed. (University of Alberta), LL.B. (Osgoode Hall Law School), LL.M. (Queen's University), of the Bar of Ontario, has been an active faculty member in the Common Law Section at the University of Ottawa Faculty of Law since 1994, assuming the role of Associate Professor in 2007. From 2006 to 2009, he also served as an Adjunct Professor with the Department of Native Studies at the University of Manitoba. He served as the Director of the Aboriginal Self-Government Program at the University of Winnipeg from 2004 to 2007. In 1998, he served as the Métis Advisor to the Senate Standing Committee on Aboriginal Peoples. From 1991 to 1994, he was the Director of the Indigenous Law Program at the Faculty of Law, University of Alberta. He holds a Bachelor of Education from the University of Alberta (1986), where he focused on elementary education and community development of Aboriginal communities. He earned his LL.B. from Osgoode Hall Law School (1989), where he was the Division Leader for the Advocacy Division of the Community Legal Aid Services Program and a caseworker for the Criminal Division. He earned his LL.M. from Queen's University in 2001 with a thesis entitled, "The Political Dimensions of Aboriginal Rights". His research interests include youth criminal justice, Métis

rights, Fetal Alcohol Spectrum Disorder, Aboriginal governance and politics, residential schools, medical liability, Aboriginal health and ethics, international human rights, and Aboriginal Constitutional law. He has published numerous articles and book chapters on issues of Aboriginal rights, law and governance, with a particular focus on Métis identity and citizenship.

John H. Currie — International Human Rights Law in the Supreme Court's Charter Jurisprudence: Commitment, Retrenchment and Retreat — In No Particular Order

John Currie is a professor of law in the Faculty of Law at the University of Ottawa, where he teaches international law, international humanitarian law, international legal regulation of the use of force, constitutional law, the law of torts and legal writing. He completed his studies at the Universities of Toronto, Ottawa and Cambridge, and was a litigator in private practice for several years before undertaking his academic career in 1997. He has been a Visiting Fellow at Oueen's University's International Study Centre in the United Kingdom, has designed and delivered courses on international and constitutional law for the Canadian Foreign Service Institute, and is an Adjunct Research Professor with the Norman Paterson School of International Affairs at Carleton University. From 2004 to 2006, Professor Currie was Scholar in Residence at Canada's Department of Foreign Affairs and International Trade, where he worked primarily on international criminal and humanitarian law issues and represented Canada before a number of United Nations and other bodies, including the International Criminal Tribunal for the Former Yugoslavia. A past-president of the Canadian Council on International Law and assistant editor of the Canadian Yearbook of International Law, Professor Currie is the author or co-author of several books, including the second edition of his treatise Public International Law (2008) as well as International Law: Doctrine, Practice and Theory (2007). He has written extensively on the Supreme Court of Canada's use of international law in its judgments.

Martha Jackman — Constitutional Castaways: Poverty and the McLachlin Court

Martha Jackman, B.A. (Queen's), LL.B. (University of Toronto), LL.M. (Yale), specializes in constitutional law, with a particular focus on the *Canadian Charter of Rights and Freedoms*, equality and socioeconomic rights. In 1988, she joined the Faculty of Law (French Common Law Program) at the University of Ottawa, where she currently occupies the Shirley E. Greenberg Chair for Women and the Legal Profession. She has acted as legal counsel in a number of Charter cases, including before the Supreme Court of Canada in the *Eldridge* and *Chaoulli* cases. She is a member of the National Steering Committee of the National Association of Women and the Law and the Co-director of the "Reconceiving Human Rights Practice" Community-University Research Alliance, funded by the Social Sciences and Humanities Research Council of Canada. In 2007 she received the Law Society of Upper Canada Medal for her contributions to the profession.

Jennifer Koshan — "Terrorism or Whatever": The Implications of *Alberta v. Hutterian Brethren of Wilson Colony* for Women's Equality and Social Justice

Jennifer Koshan is Associate Professor, Associate Dean Research and Graduate Program Director at the University of Calgary Faculty of Law. She has a B.Sc. (1985) and LL.B. (1988) from the University of Calgary, and an LL.M. from the University of British Columbia (1997). Before joining the Faculty of Law in 2000, Jennifer worked for several years as a Crown Prosecutor in the Northwest Territories, and for the West Coast branch of the Women's Legal Education and Action Fund (LEAF) as Legal Director. She is a founding member of the Women's Court of Canada and continues to volunteer with LEAF and other equality organizations. In 2004 Jennifer was awarded The University of Calgary Faculty Association's Community Service Award for her contributions to the equality-seeking community. Her research and teaching interests are in the areas of constitutional law (particularly equality rights), human rights, violence against women and public interest advocacy. Jennifer is also an active blogger and coordinates ABlawg, The University of Calgary Faculty of Law Blog on Developments in Alberta Law.

Graham Mayeda — Between Principle and Pragmatism: The Decline of Principled Reasoning in the Jurisprudence of the McLachlin Court

Graham Mayeda is an Associate Professor at the Faculty of Law, University of Ottawa. His research explores the role of difference in various legal contexts. His recent work has focused on the impact of international trade and investment law on developing countries. He has begun a new project on theories of global justice, which aims at articulating a cosmopolitan concept of global justice that takes into account the diverse perspectives of developing countries. He is also interested in the impact of cultural, socio-economic, racial and gender difference in Canadian criminal law and the law of evidence.
